

(PATON STREET, ALLOA) (TEMPORARY ROAD CLOSURE) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Paton Street, Alloa) (Temporary Road Closure) Order 2022" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 25th April 2022 and will remain in operation until 1600 hours on Friday 29th April 2022.
- 2. The effect of this Order shall be to close to vehicles:-

During the period from 0800 hours on Monday 25th April 2022 until 1600 hours on Friday 29th April 2022, on the section of roads described in Schedule. The temporary closure is required for carriageway resurfacing and for the safety of the workforce and members of the public.

The order runs from 0800 hours on Monday 25th April 2022 until 1600 hours on Friday 29th April 2022 and is required for carriageway resurfacing and for the safety of the workforce and members of the public. 
