



**(VARIOUS STREETS, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 16th May 2022 and will remain in operation until 1600 hours on Friday 27th May 2022.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 16th May 2022 until 1600 hours on Friday 27th May 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for carriageway resurfacing and safety of workforce and members of the public.

The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 3rd May 2022: where there will be a temporary prohibition of driving, parking and loading at **Smithfield Loan, Alloa** (from its junction with Grange Road westwards until its junction with Bellevue Road, a distance of 290 metres or thereby), **Medwyn Place, Alloa** (from its junction with Smithfield Loan southwards until its junction with Forbes Street, a distance of 92 metres or thereby). **Diversion:** Via Bellevue Road, Caledonian Road, Grant Street and vice versa. The order runs from 0800 hours on Monday 16th May 2022 until 1600 hours on Friday 27th May 2022. The works are required for carriageway resurfacing and safety of workforce and members of the public. 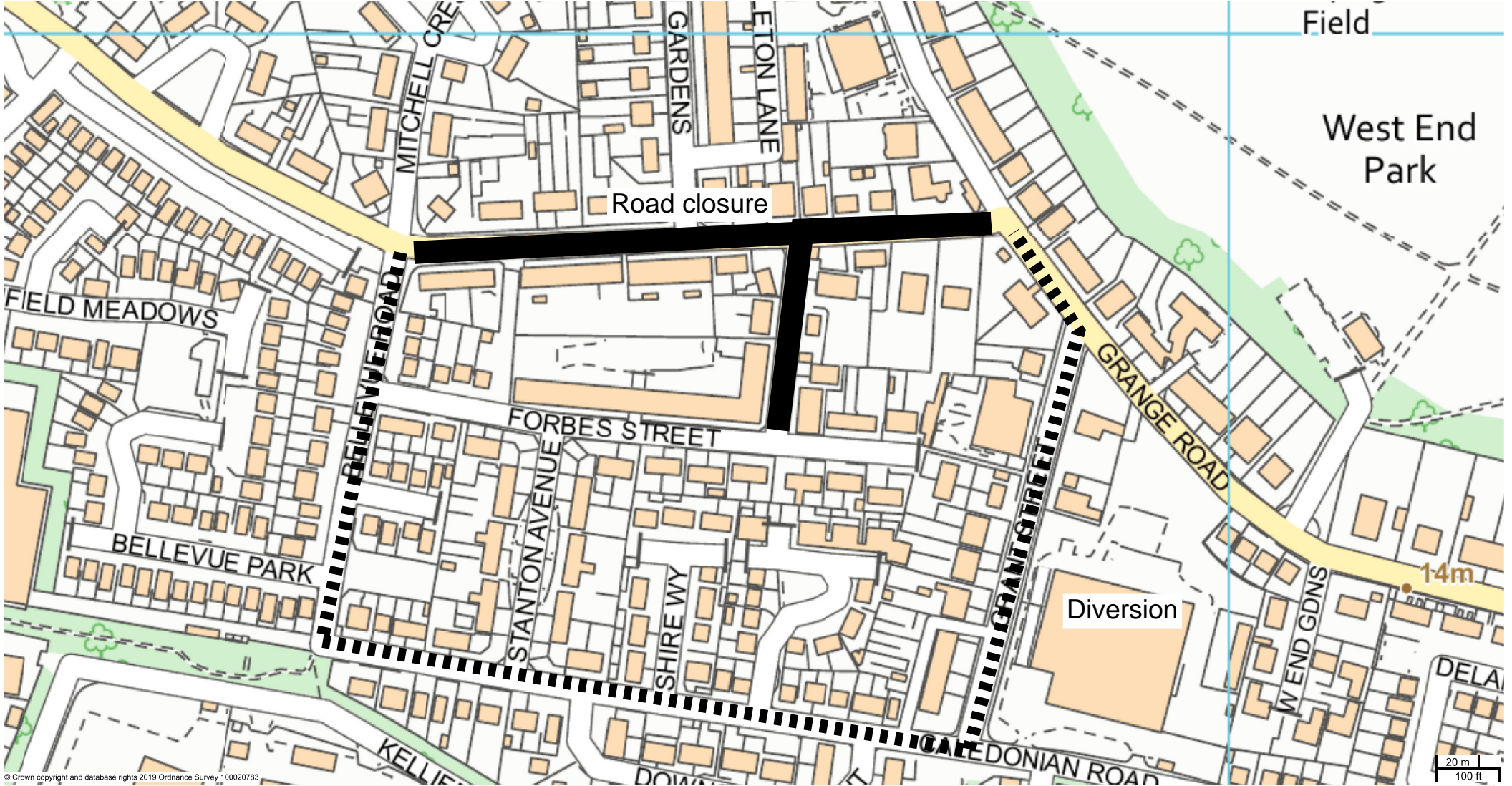
