

(COOPERAGE WAY, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Cooperage Way, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 23rd May 2022 and will remain in operation until 1615 on Tuesday 31st May 2022.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 23rd May 2022 until 1615 hours on Tuesday 31st May 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to facilitate mains laying and mains connection.

The Council has made "The Clackmannanshire Council (Cooperage Way, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 3rd May 2022: where there will be a temporary prohibition of driving, parking and loading at **Cooperage Way, Alloa** (from its junction with Carsebridge Road northwards for a distance of 25 metres or thereby). Diversion: Via Carsebridge Road, Whins Road, Carsebridge Court, Cooperage Way and vice versa. The order runs from 0800 hours on Monday 23rd May 2022 until 1615 hours on Tuesday 31st May 2022.
