

(BROOK STREET, ALVA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Brook Street, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 6th June 2022 and will remain in operation until 1700 hours on Sunday 3rd July 2022.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 6th June 2022 until 1700 hours on Sunday 3rd July 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to facilitate the streetscape enhancement works being carried out on Stirling Street/East Stirling Street. Diversions will be signposted.

The Council has made "The Clackmannanshire Council (Brook Street, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 18th May 2022: where there will be a temporary prohibition of driving, parking and loading at **Brook Street**, **Alva** (from its junction with A91 Stirling Street northwards for a distance of 30 metres or thereby) and (from its junction with A91 Stirling Street southwards for a distance of 50 metres or thereby. The order runs from 0800 hours on Monday 6th June 2022 until 1700 hours on Sunday 3rd July 2022. The works are required to facilitate the streetscape enhancement works being carried out on Stirling Street/East Stirling Street. Diversions will be signposted.
