



**(VARIOUS STREETS, ALLOA)
(TEMPORARY ROAD AND FOOTWAY CLOSURES) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Road and Footway Closures) Order 2022" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 18th July 2022 and will remain in operation until 1615 hours on Friday 7th October 2022.
2. The effect of this Order shall be to close to vehicles and pedestrians:-

During the period from 0800 hours on Monday 18th July 2022 until 1615 hours on Friday 7th October 2022, on the section of roads described in Schedules 1 and 2. The temporary closure is required to facilitate main laying and mains connection by SGN.

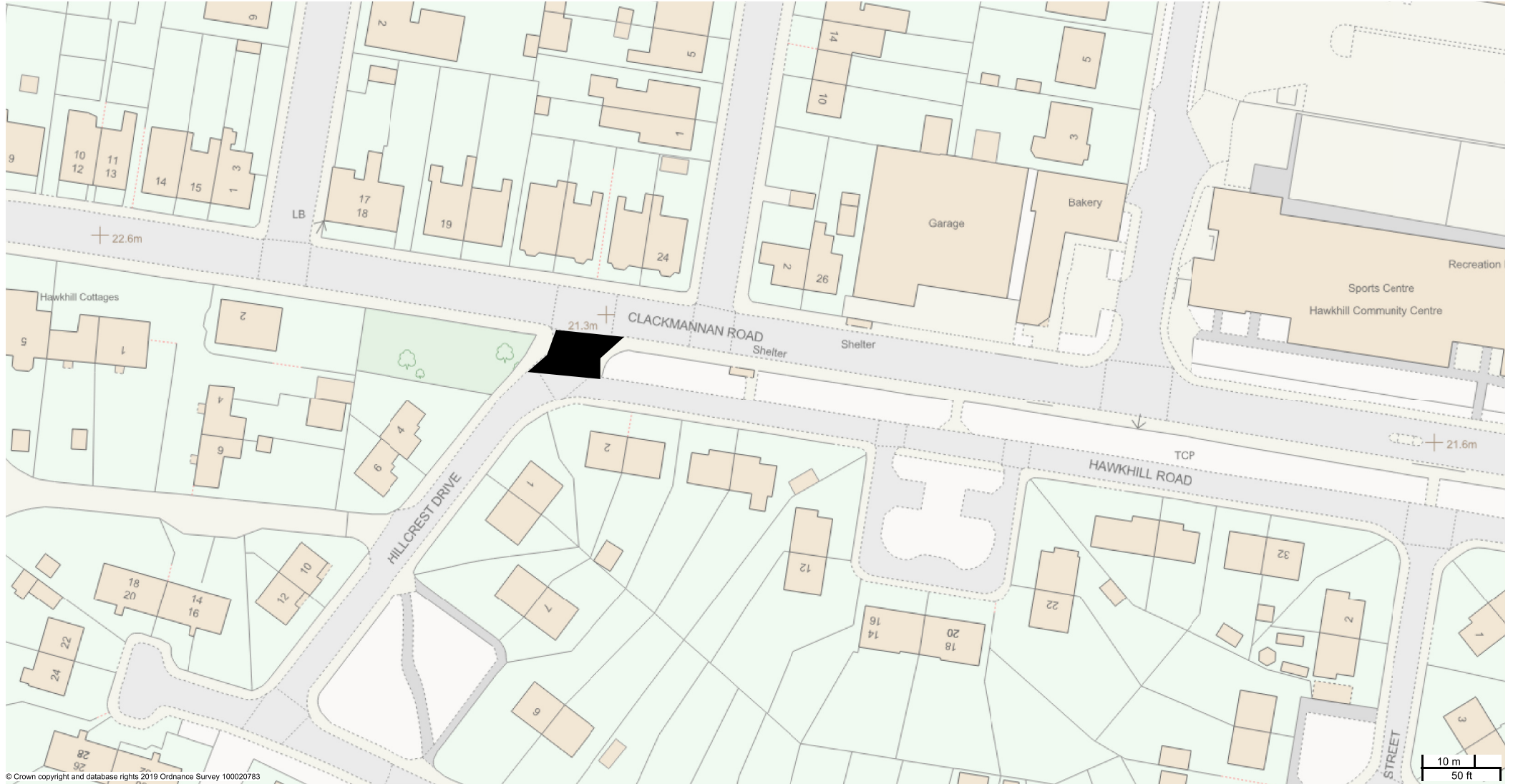
