



**(LAWSWELL, FISHCROSS)
(TEMPORARY ROAD AND FOOTWAY CLOSURE) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Lawswell, Fishcross) (Temporary Road and Footway Closure) Order 2022" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 1st August 2022 and will remain in operation until 1600 hours on Friday 12th August 2022.
2. The effect of this Order shall be to close to vehicles and pedestrians:-

During the period from 0800 hours on Monday 1st August 2022 until 1600 hours on Friday 12th August 2022, on the section of roads described in Schedules 1 and 2. The temporary closure is required for footway resurfacing and safety of the workforce and members of the public.

The Council has made "The Clackmannanshire Council (Lawswell, Fishcross) (Temporary Road and Footway Closure) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 22nd June 2022: to close to vehicles and pedestrians at the section of road at (Schedule 1) **Lawswell, Fishcross** (from a point XX metres or thereby east its junction with A908, eastwards then northwards then eastwards for a distance of 230 metres or thereby). Diversion: Via A908, Pitfairn Road and vice versa. (Schedule 2) **Lawswell, Fishcross** (Both Sides - from a point 28 or thereby east of its junction with the A908, eastwards then northwards then eastwards for a distance of 230 metres or thereby). 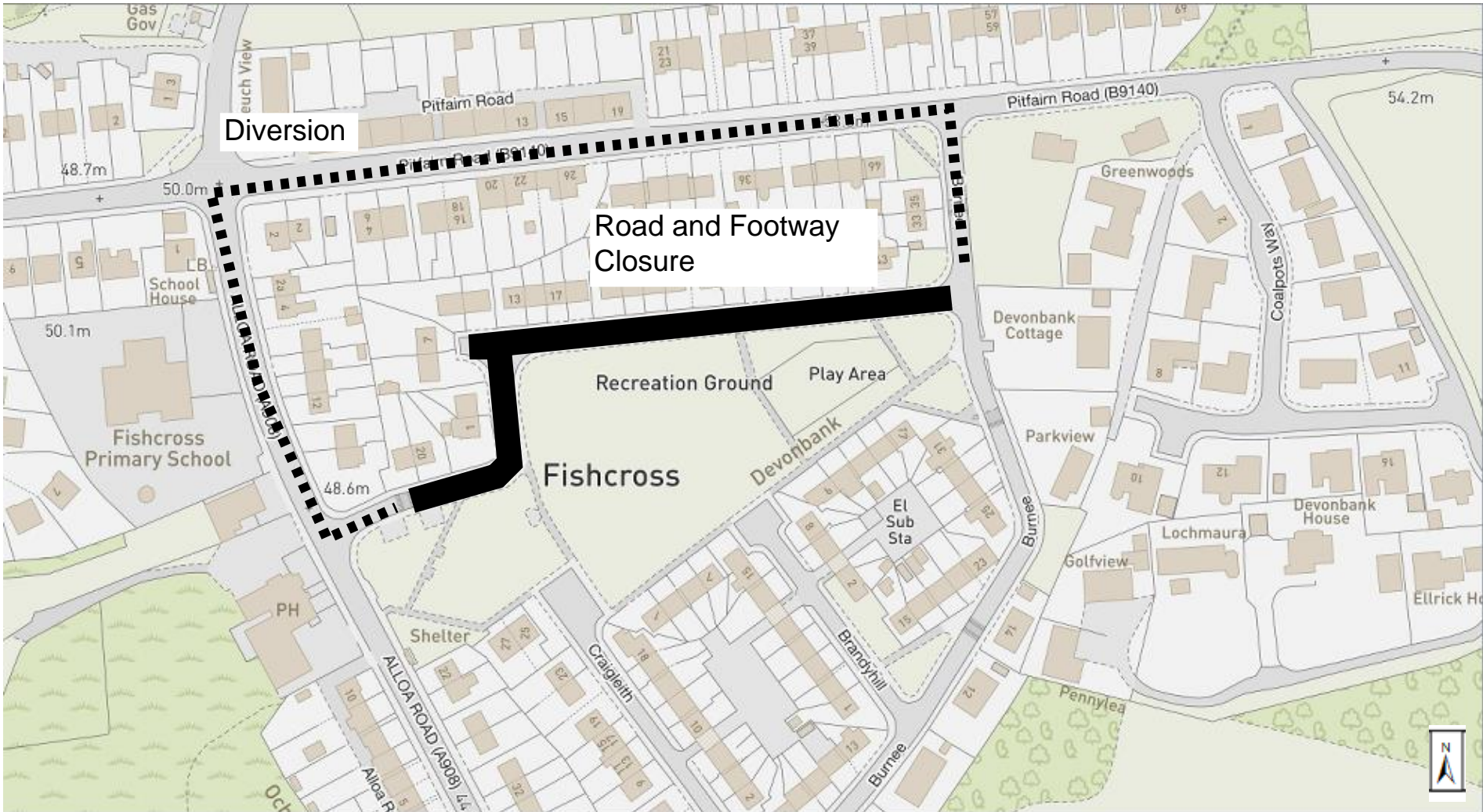
