

## (MILL STREET, ALLOA) (TEMPORARY PARKING SUSPENSION) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Mill Street, Alloa) (Temporary Parking Suspension) Order 2022" and notwithstanding the date hereof shall come into operation at 0800 hours on Sunday 4<sup>th</sup> September 2022 and will remain in operation until 1700 hours on that day (Schedule1) and at 0800 hours on Monday 5<sup>th</sup> September 2022 and will remain in operation until 1615 hours on Friday 23<sup>rd</sup> September 2022 (Schedule 2).
- 2. The effect of this Order shall be to suspend parking during:-

The period from 0800 hours until 1700 hours on Sunday 4<sup>th</sup> September 2022 (Schedule 1) and from 0800 hours on Monday 5<sup>th</sup> September 2022 until 1615 hours on Friday 23<sup>rd</sup> September 2022, on the section described in the Schedules 1 and 2 attached. The temporary parking suspension is required to facilitate pole replacement by BT (Schedule 1) and is required to facilitate vehicle parking and storage or plant by SGN (Schedule 2).

#### The Clackmannanshire Council (Mill Street, Alloa) (Temporary Parking Suspension) Order 2022

The Council has made "The Clackmannanshire Council (Mill Street, Alloa) (Temporary Parking Suspension) Order 2022", under the Road Traffic Regulation Act 1984 (as amended) on 9<sup>th</sup> August 2022: (Schedule 1) to suspend parking at **Mill Street**, **Alloa** – North West Side – from a point 14 metres northeast of its junction with High Street, north eastwards for a distance of 55 metres or thereby; **Mill Street**, **Alloa** – South East Side – from a point 14 metres northeast of its junction with High Street or thereby. The order runs from 0800 hours until 1700 hours on Sunday 4<sup>th</sup> September 2022 and is required to facilitate pole replacement by BT.

(Schedule 2) to suspend parking at **Mill Street, Alloa** – North West Side – from a point 32 metres northeast of its junction with High Street, north eastwards for a distance of 25 metres or thereby. The order runs from 0800 hours on Monday 5<sup>th</sup> September 2022 until 1615 hours on Friday 23<sup>rd</sup> September 2022 and is required to facilitate vehicle parking and storage of plant by SGN.
