

### (OCHIL ROAD, ALVA) (TEMPORARY NO PARKING RESTRICTION) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Ochil Road, Alva) (Temporary No Parking Restriction) Order 2022" and notwithstanding the date hereof shall come into operation at 1800 hours on Saturday 10<sup>th</sup> September 2022 and will remain in operation until 2130 hours on that day.
- 2. The effect of this Order shall be to suspend parking during:-The period from 1800 hours until 2130 hours on Saturday 10<sup>th</sup> September 2022, on the section described in the Schedule attached. The temporary no parking restriction is required to stop vehicles parking and blocking access during the Alva Illuminations.


