



**(VARIOUS STREETS, MENSTRIE)
(TEMPORARY FOOTWAY CLOSURE) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Menstrie) (Temporary Footway Closure) Order 2022" and notwithstanding the date hereof shall come into operation at 0730 hours on Monday 10th October 2022 and will remain in operation until 1730 hours on Monday 24th October 2022.
- The effect of this Order shall be to close to pedestrians:-
The period from 0730 hours on Monday 10th October 2022 until 1730 hours on Monday 24th October 2022, on the section described in the Schedule attached. The temporary footway closure is required for carriageway and footway resurfacing.

The Clackmannanshire Council (Various Streets, Menstrie) (Temporary Footway Closure) Order 2022

The Council has made "The Clackmannanshire Council (Various Streets, Menstrie) (Temporary Footway Closure) Order 2022", under the Road Traffic Regulation Act 1984 (as amended) on 15th September 2022: to close to pedestrians at **Castle Street** – (North Side - from its junction with Brook Street, eastwards, then northwards then eastwards for a distance of 92 metres of thereby.) (South Side – From its junction with Menstrie Place northwards for a distance of 15 metres or thereby.) **Menstrie Place** – (North and East Side – From its junction with Castle Road eastwards then southwards then eastwards for a distance of 123 metres or thereby.) (South and West Side – From a point 22 metres south of its junction with Castle Road eastwards then southwards then eastwards for a distance of 55 metres or thereby.) (South Side – From its junction with Elmbank westwards for a distance of 10 metres or thereby.) The order runs from 0730 hours on Monday 10th October 2022 until 1730 hours on Monday 24th October 2022, and is required for carriageway and footway resurfacing. 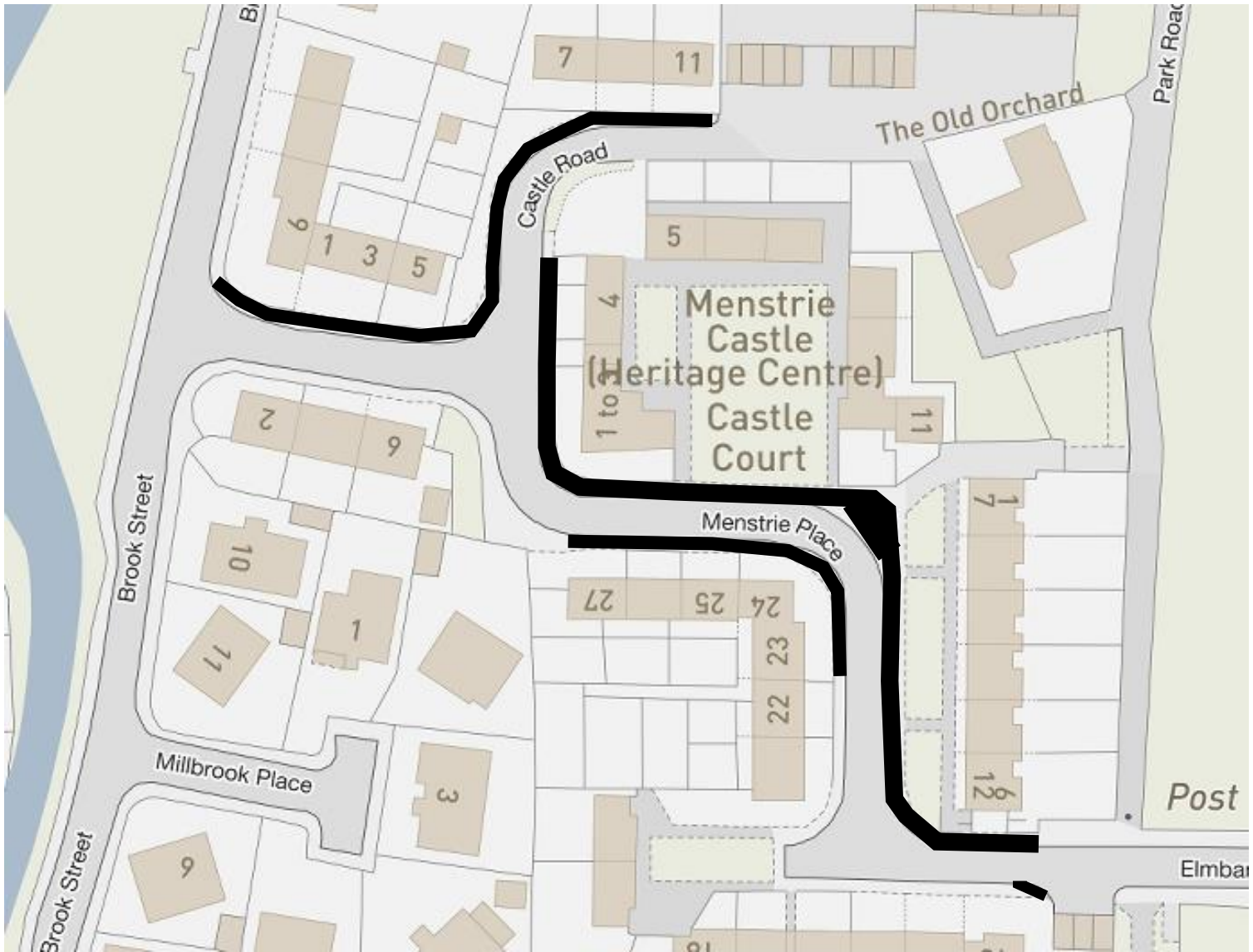
