

(A823 MUCKHART) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (A823 Muckhart) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0915 hours until 1530 hours each day from Monday 17th October 2022 and will remain in operation for a period of 2 weeks.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0915 hours until 1530 hours each day from Monday 17th October 2022 for a period of 2 weeks, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for resurfacing works.
