

(WESTBOURNE AVENUE, TILLICOULTRY) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Westbourne Avenue, Tillicoultry)
 (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date
 hereof, the Schedule shall come into operation at 0900 hours on Wednesday 19th October 2022
 and will remain in operation until 2300 hours on Friday 28th October 2022.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0900 hours on Wednesday 19th October 2022 until 2300 hours on Friday 28th October 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to dig to repair protruding connection to main sewer.

The Council has made "The Clackmannanshire Council (Westbourne Avenue, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 5th October 2022: where there will be a temporary prohibition of driving, parking and loading at **Westbourne Avenue, Tillicoultry** (From its junction with Ravenswood eastwards for a distance of 70 metres or thereby). Diversion: Via Westbourne Avenue, Fir Park, Stalker Avenue and vice versa. The order runs from 0900 hours on Wednesday 19th October 2022 until 2300 hours on Friday 28th October 2022. 
