

(A908 WHINS ROAD, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (A908 Whins Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 2200 hours on Monday 14th November 2022 and will remain in operation until 0600 hours on Tuesday 15th November 2022.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 2200 hours on Monday 15th November 2022 until 0600 hours on Tuesday 15th November 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to carry out a rail bridge inspection works overnight.

The Council has made "The Clackmannanshire Council (A908 Whins Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 4th October 2022: where there will be a temporary prohibition of driving, parking and loading at **Whins Road, Alloa** (From a point 195 metres or thereby north of its junction with Shillinghill Roundabout northwards for a distance of 105 metres or thereby). Diversion: Via A907 Clackmannan Road, B909, A908 Whins Road and vice versa. The order runs from 2200 hours on Monday 14th November 2022 until 0600 hours on Tuesday 15th November 2022. 
