

(VARIOUS STREETS, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 1800 hours on Friday 25th November 2022 and will remain in operation until 2000 hours on Saturday 26th November 2022.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 1800 hours on Friday 25th November 2022 until 2000 hours on Saturday 26th November 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary for the switching-on ceremony for the Christmas Lights.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 20th October 2022: where there will be a temporary prohibition of driving, parking and loading at **High Street**, **Alloa** (From its junction with Drysdale Street to its junction with Mill Street, a distance of 130 metres or thereby); **Mill Street**, **Alloa** (From its junction with Mar Street to its junction with Drysdale Street, a distance of 150 metres or thereby. Alternative Route: There is no alternative route available. The order runs from 1800 hours on Friday 25th November 2022 until 2000 hours on Saturday 26th November 2022.
