



**(VARIOUS STREETS, ALLOA)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 12<sup>th</sup> December 2022 and will remain in operation until 1800 hours on Sunday 18<sup>th</sup> December 2022.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 12<sup>th</sup> December 2022 until 1800 hours on Sunday 18<sup>th</sup> December 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for installation of a new BT duct.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 10<sup>th</sup> November 2022: where there will be a temporary prohibition of driving, parking and loading at **Coalgate, Alloa** (From its junction with Mill Street southwards for a distance of 55 metres or thereby); **West Vennel, Alloa** (For its entirety, a distance of 20 metres or thereby). The order runs from 0800 hours on Monday 12<sup>th</sup> December 2022 until 1800 hours on Sunday 18<sup>th</sup> December 2022. The works are required for installation of a new BT duct. 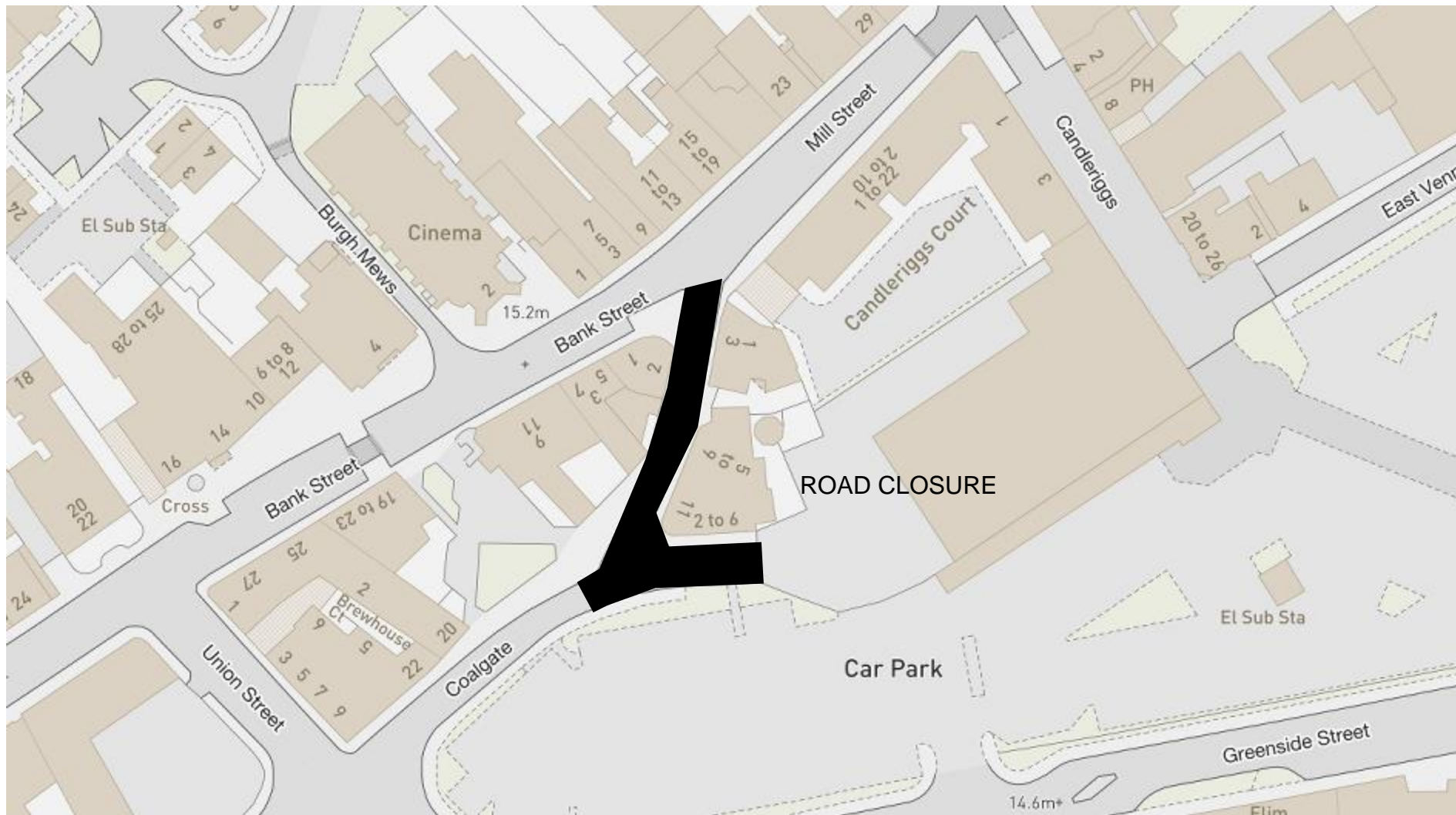
