This Order may be cited as "The Clackmannanshire Council (A908 Fishcross-Devonside) (Temporary Road Closure) Order 2023" and notwithstanding the date hereof, Schedule shall come into operation at 0900 hours on Sunday 12<sup>th</sup> March 2023 and will remain in operation until 1130 hours on that day.

The period from 0900 hours until 1130 hours on Sunday 12<sup>th</sup> March 2023, on the section of roads described in Schedule. The temporary closure is necessary to facilitate the safe passage of participants in the Alloa Half Marathon.

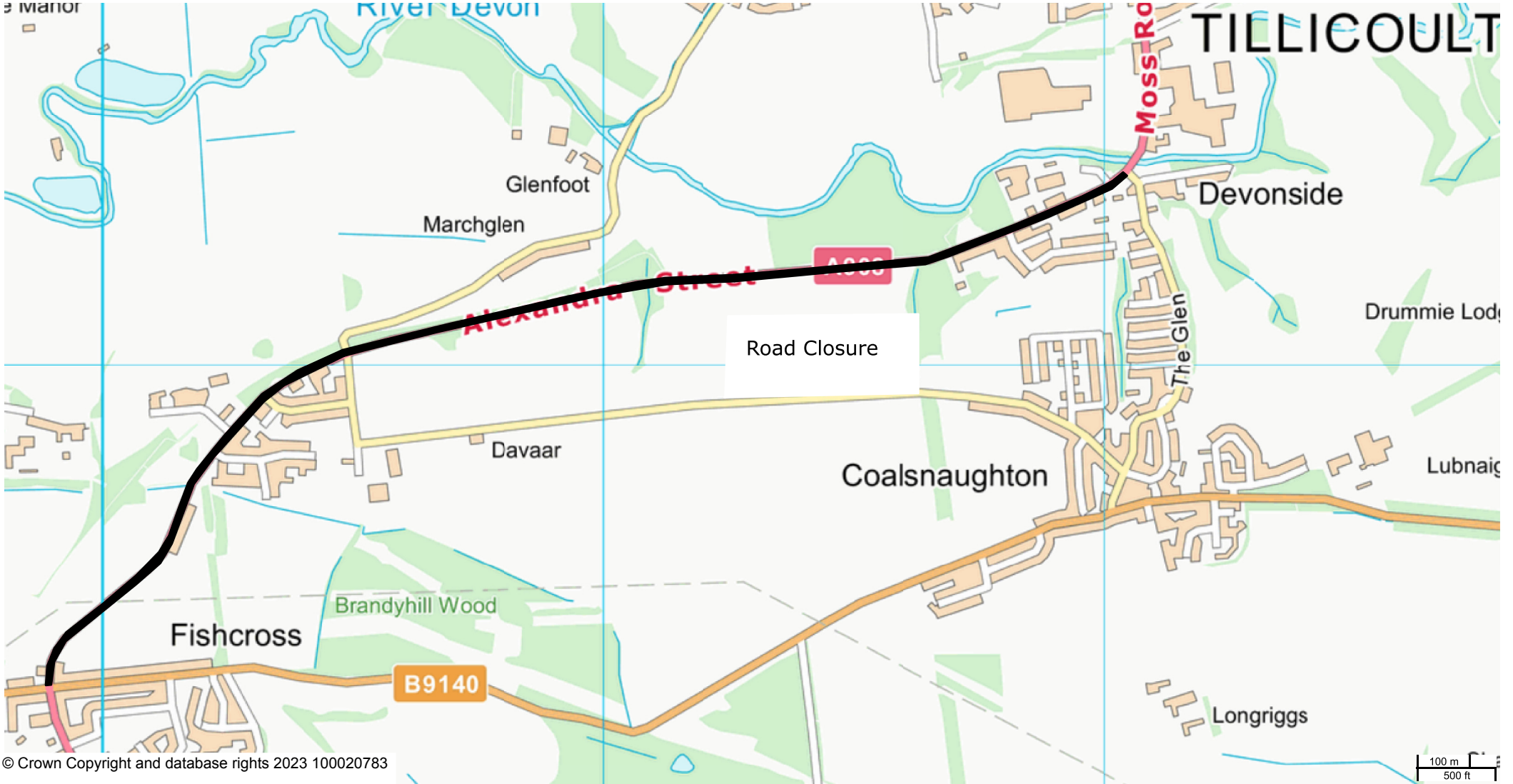
