

(HENRY STREET, ALVA) (TEMPORARY REMOVAL OF ONE WAY TRAFFIC) ORDER 2023

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Henry Street, Alva) (Temporary Removal of One Way Traffic) Order 2023" and notwithstanding the date hereof, Schedule shall come into operation at 0900 hours on Sunday 12th March 2023 and will remain in operation until 1200 hours on that day or until race has cleared section.
- 2. The effect of this Order shall be that there will be no waiting at any time during:-The period from 0900 hours until 1200 hours on Sunday 12th March 2023 or until race has cleared section, on the section of roads described in Schedule. The temporary removal of One Way Traffic to allow traffic to access and exit with care during the Alloa Half Marathon.
