



THE CLACKMANNANSHIRE COUNCIL
(CLACKMANNAN ROAD, ALLOA)
(PROHIBITION OF RIGHT TURN) ORDER 2023

The CLACKMANNANSHIRE COUNCIL in exercise of its powers under the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, and having complied with the requirements of The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999, hereby makes the following order:

1. This Order may be cited as "The Clackmannanshire Council (Clackmannan Road, Alloa) (Prohibition of Right Turn) Order 2023" and shall come into operation on the 15 June 2023.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. No person shall drive, or cause or permit to be driven, any vehicle on Clackmannan Road, Alloa, so as to turn right into McDonald's Restaurant car park, Alloa.
4. In this Order except where the context otherwise requires the following expressions have the meaning hereby respectively assigned to them:
 - (a) "road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and includes any verge or footway;
 - (b) "vehicle" means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along road whether by animal or mechanical power;

5. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.

11. Insofar as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act of 1984 and which imposes a restriction or prohibition on waiting by vehicles or grants an exemption from such restriction or prohibition then the effect of this Order shall prevail.

The Council proposes to make the above Order in accordance with Part III of Schedule 9 to the 1984 Act, and having complied with the requirements of The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999 to prohibit a right turn into McDonald's Restaurant car park for safety reasons:

Clackmannan Road, Alloa (Eastbound) – site location is at a point 115 metres west of the Clackmannan Road Roundabout . Alternative means of access is by continuing on Clackmannan Road eastbound to the Clackmannan Road roundabout and return to Clackmannan Road westbound and turn left into McDonald's Restaurant. Full details are available on www.clacks.gov.uk, where objectors must state their reasons for objection by 31/03/23.

The Council has made the above Order in accordance with Part III of Schedule 9 to the 1984 Act, and having complied with the requirements of The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999 to prohibit a right turn into McDonald's Restaurant car park for safety reasons: Clackmannan Road, Alloa (Eastbound) – site location is at a point 115 metres west of the Clackmannan Road Roundabout . Alternative means of access is by continuing on Clackmannan Road eastbound to the Clackmannan Road roundabout and return to Clackmannan Road westbound and turn left into McDonald's Restaurant.. Any person wishing to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the aforesaid Act or that if any requirement therein has not been complied with, may, within six weeks from 7 June 2023 apply to the Court of Session for this purpose.
