

(ALLOA TOWN CENTRE) (ONE-WAY TRAFFIC) CONSOLIDATION ORDER (AMENDMENT NO. 1) 2023

The CLACKMANNANSHIRE COUNCIL in exercise of the powers conferred on them by Section 1(1) and (2), 2(1) to (3) and 4(1) of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Parts III and IV of Schedule 9 of the said Act of 1984, hereby make the following Order:-

- This Order may be cited as "The Clackmannanshire Council (Alloa Town Centre) 1. (One-Way Traffic) Consolidation Order (Amendment No. 1) Order 2023" and shall come into operation on the DATE 2023.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. This Order amends "The Clackmannanshire Council (Alloa Town Centre) (One-Way Traffic) Consolidation Order 2018" by amending the Schedule to that order to reverse the one-way direction on the length of road on Mill Street, Alloa as detailed in the Schedule to this amendment order.
- 4. No person shall drive or cause or permit to be driven any vehicle on the lengths of roads specified in the Schedule to this Order other than in the direction specified in the said Schedule and shown on the plan annexed and signed as relative hereto.
- 5. Nothing in Article 4 of this Order shall apply to the driving of any small mechanical road cleansing vehicle being used in pursuance of statutory powers or duties.

6. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.
