



**(VARIOUS STREETS, ALLOA)
(TEMPORARY PROHIBITION OF PARKING AND LOADING) ORDER 2023**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Parking and Loading) Order 2023" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 3rd April 2023 until 1600 hours on Monday 3rd July 2023.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 3rd April 2023 until 1600 hours Monday 3rd July 2023, on the section of roads described in Schedule. The temporary prohibition of parking and loading is required for mains replacement.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Parking and Loading) Order 2023, under the Road Traffic Regulation Act 1984 (as amended) on 7th March 2023: Schedule – where there will be a temporary prohibition of parking and loading at **Mitchell Crescent, Alloa** (Both Sides – From its junction with Smithfield Loan, northwards until its junction with Dirleton Gardens, a distance of 235 metres or thereby). **Dirleton Gardens, Alloa** (Both Sides – From its junction with Smithfield Loan, northwards for a distance of 175 metres or thereby). **Smithfield Loan, Alloa** (Both Sides – From its junction with Grange Road, westwards for a distance of 190 metres or thereby). 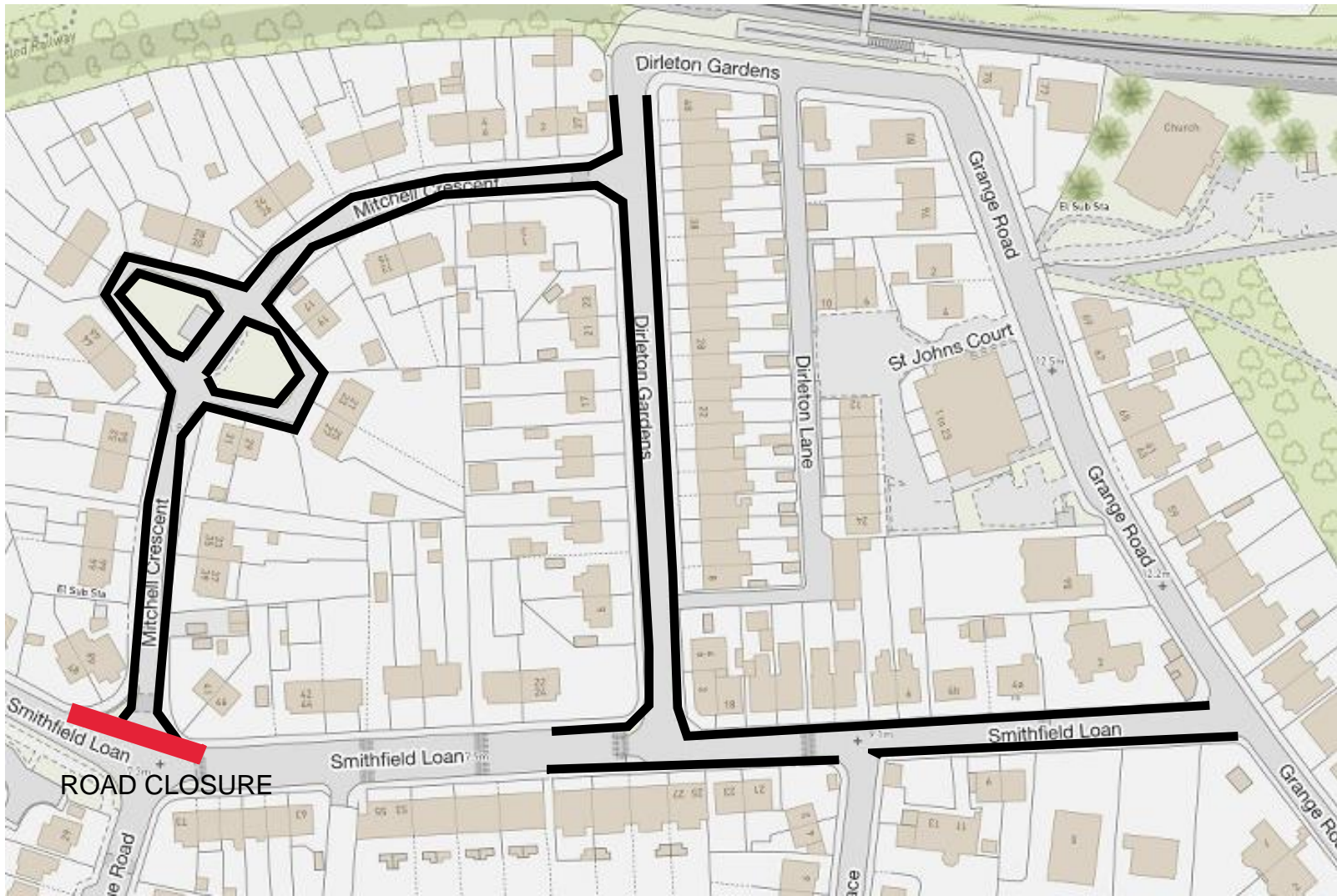
