(TALORCAN, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2023

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Talorcan, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2023" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours until 1800 on Friday 16th June 2023.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0930 hours until 1800 hours on Friday 16th June 2023, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for iron work repairs.

Diversion via Taran, Galan, Alloa Park Drive and vice versa. The order runs from 0930 hours until 1800 hours on Friday 16th June 2023. The works are required for iron work repairs.
