



**(MAIN STREET, TULLIBODY)  
(TEMPORARY FOOTWAY CLOSURE) ORDER 2023**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Main Street, Tullibody) (Temporary Footway Closure) Order 2023" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Thursday 14<sup>th</sup> September 2023 until 1800 hours on Saturday 16<sup>th</sup> September 2023 and 0800 hours on Tuesday 17<sup>th</sup> October 2023 until 1800 hours on Friday 20<sup>th</sup> October 2023..
  
2. The effect of this Order shall be to close to pedestrians;  
The period from 0800 hours on Thursday 14<sup>th</sup> September 2023 until 1800 hours on Saturday 16<sup>th</sup> September 2023 and 0800 hours on Tuesday 17<sup>th</sup> October 2023 until 1800 hours on Friday 20<sup>th</sup> October 2023, on the section of footway described in Schedule. The temporary footway closure is required for excavation for pole roots/cabinets and associated ducting in the footway. To install new telecom pole and cab. Rigging, integration and testing within existing telecoms site.
