



**(A907 CLACKMANNAN ROAD, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2023**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 Clackmannan Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2023" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours until 1800 hours on Sunday 24th September 2023.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours until 1800 hours on Sunday 24th September 2023, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for carriageway patching and safety of the workforce and members of the public. Access for residents only, no through access.

Diversion via B909, A908 Whins Road and vice versa. HGV diversion route due to low bridge via B909, A908 Hallpark, B908 Parkhead Road, B908 Sunnyside Road, Mar Place, A907 King Street and vice versa. The order runs from 0800 hours until 1800 hours on Sunday 24th September 2023. The works are required for carriageway patching and safety of the workforce and members of the public. 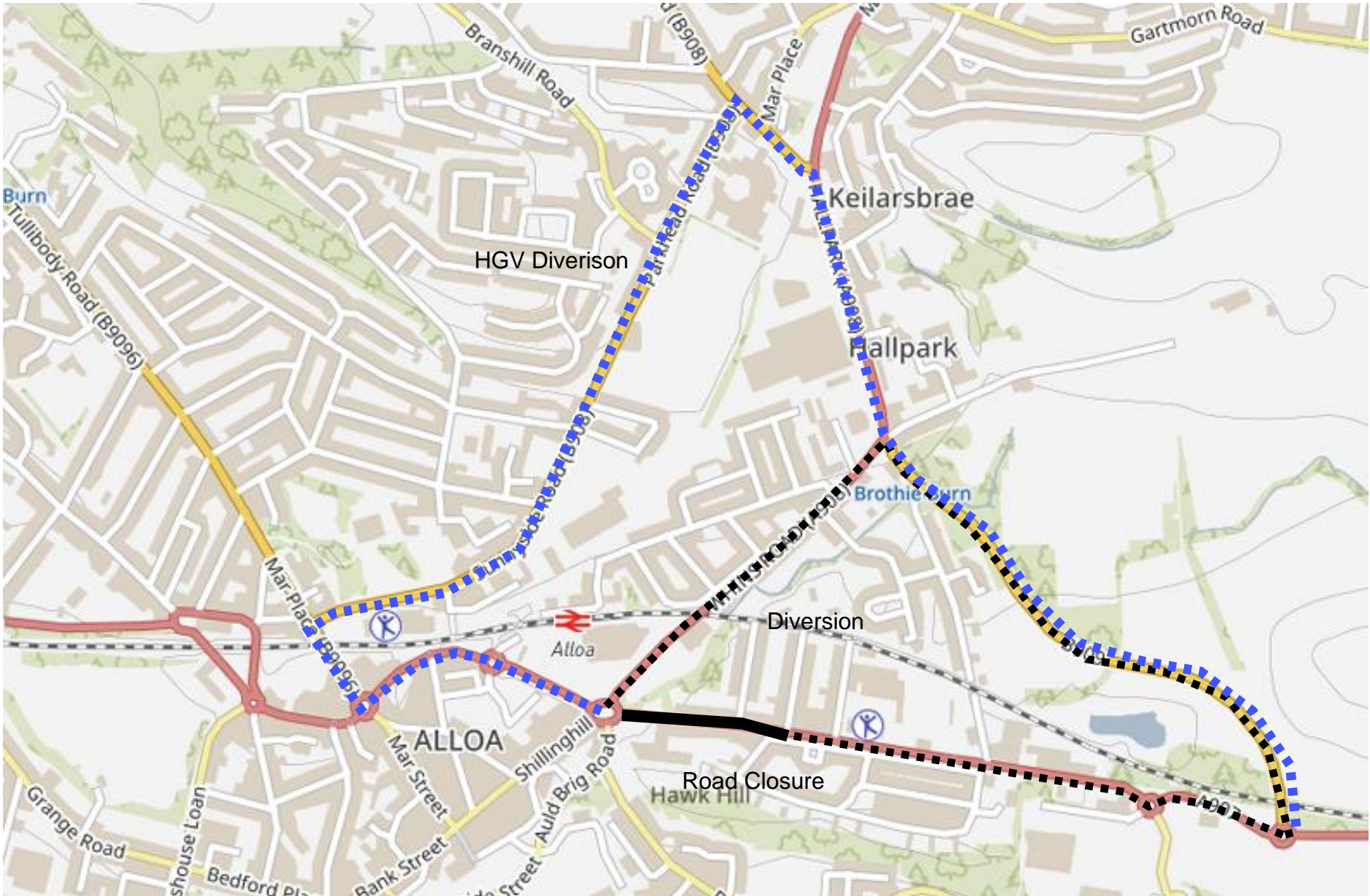
