



**(VARIOUS STREETS, ALLOA)  
(TEMPORARY NO PARKING) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary No Parking) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 29<sup>th</sup> January 2024 until 1600 hours on Monday 8<sup>th</sup> April 2024 (only when traffic management is in situ).
2. The effect of this Order is that there will be no parking at any time (only when traffic management is in situ) during:

The period from 0800 hours on Monday 29<sup>th</sup> January 2024 until 1600 hours on Monday 8<sup>th</sup> April 2024 (only when traffic management is in situ), on the section of roads described in Schedule. The temporary prohibition of parking is required for SGN mains replacement.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary No Parking) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 3<sup>rd</sup> January 2024: where there will be a temporary no parking at **B908 Parkhead Road, Alloa** (Both Sides – From a point 85 metres or thereby north of its junction with Ashley Terrace, northwards for a distance of 338 metres or thereby). **B908 Sunnyside Road, Alloa** (Both Sides – From its junction with Parkway, northwards for a distance of 462 metres or thereby). **Erskine Street, Alloa** (Both Sides – From its junction with Hill Street, southwards for a distance 55 metres or thereby). **Erskine Street, Alloa** (Both Sides – From its junction with B908 Sunnyside Road, southwards for a distance of 47 metres or thereby). **Sunnyside Court, Alloa** (Both Sides - From its junction with Erskine Street eastwards for a distance of 146 metres or thereby). **Ashley Terrace, Alloa** (Both Sides - From its junction with B908 Sunnyside Road, westwards for a distance of 160 metres or thereby). **Ashley Terrace, Alloa** (Both Sides - From its junction with Shaftesbury Street, westwards for a distance of 207 metres or thereby). **Forebraes, Alloa** (Both sides – From its junction with Ashley Terrace, northwards for a distance of 90 metres or thereby). **Nevis Crescent, Alloa** (Both Sides – From its junction with Forebraes, eastwards for a distance of 190 metres or thereby). **Ochil Street, Alloa** (Both Sides – From its junction with B9096 Tullibody Road, southwards for a distance of 195 metres or thereby). **B908 Parkway, Alloa** (Both Sides – From its junction with B908 Sunnyside Road, southwards for a distance of 233 metres or thereby). The order runs from 0800 hours on Monday 29<sup>th</sup> January 2024 until 1600 hours on Monday 8<sup>th</sup> April 2024 (only when traffic management is in situ). 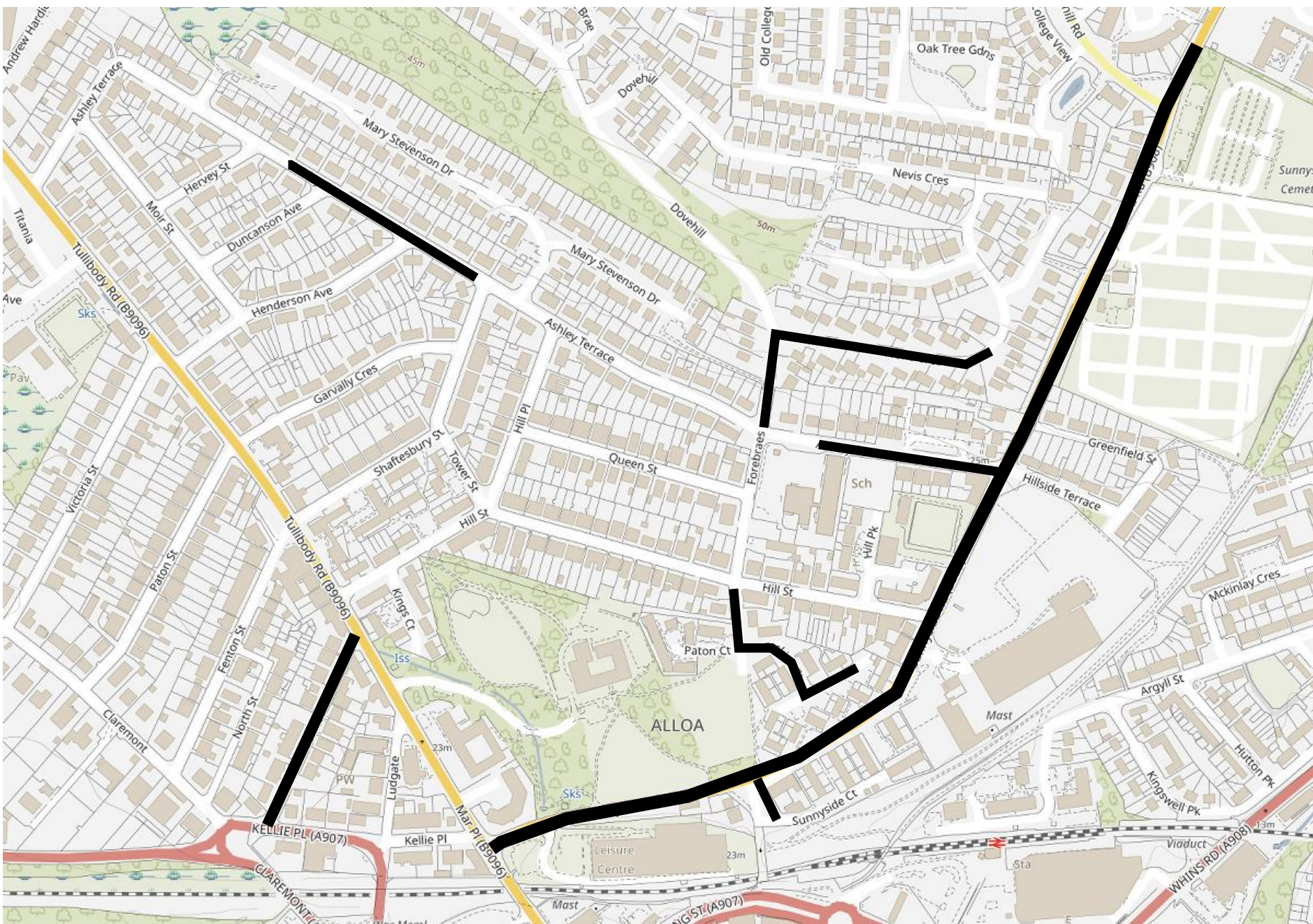
