



**(VARIOUS STREETS, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof. Schedule 1 shall come into operation at 0800 hours on Monday 29th January 2024 until 1600 hours on Monday 12th February 2024. Schedule 2 shall come into operation at 0800 hours on Monday 18th March 2024 until 1600 hours on Sunday 7th April 2024.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 29th January 2024 until 1600 hours on Monday 12th February 2024, on the section of road described in Schedule 1. The period from 0800 hours on Monday 18th March 2024 until 1600 hours on Sunday 7th April 2024, on the section of road described in Schedule 2. The temporary prohibition of driving, parking and loading is required for SGN mains replacement.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 3rd January 2024: Schedule 1 where there will be a temporary prohibition of driving, parking and loading at **Ochil Street, Alloa** (From its junction with B9096 Tullibody Road southwards for a distance of 190 metres or thereby). Schedule 1 order runs from 0800 hours on Monday 29th January 2024 until 1600 hours on Monday 12th February 2024. Schedule 2 where there will be a temporary prohibition of driving, parking and loading at **B908 Parkhead Road** (From its junction with Branshill Road southwards for a distance of 336 metres or thereby). Diversion via B908 Parkhead Road, A908 Hallpark, A908 Whins Road, A907 King Street, B9096 Mar Place, B908 Parkway, B908 Sunnyside Road and vice versa. Schedule 2 order runs from 0800 hours on Monday 18th March 2024 until 1600 hours on Sunday 7th April 2024. 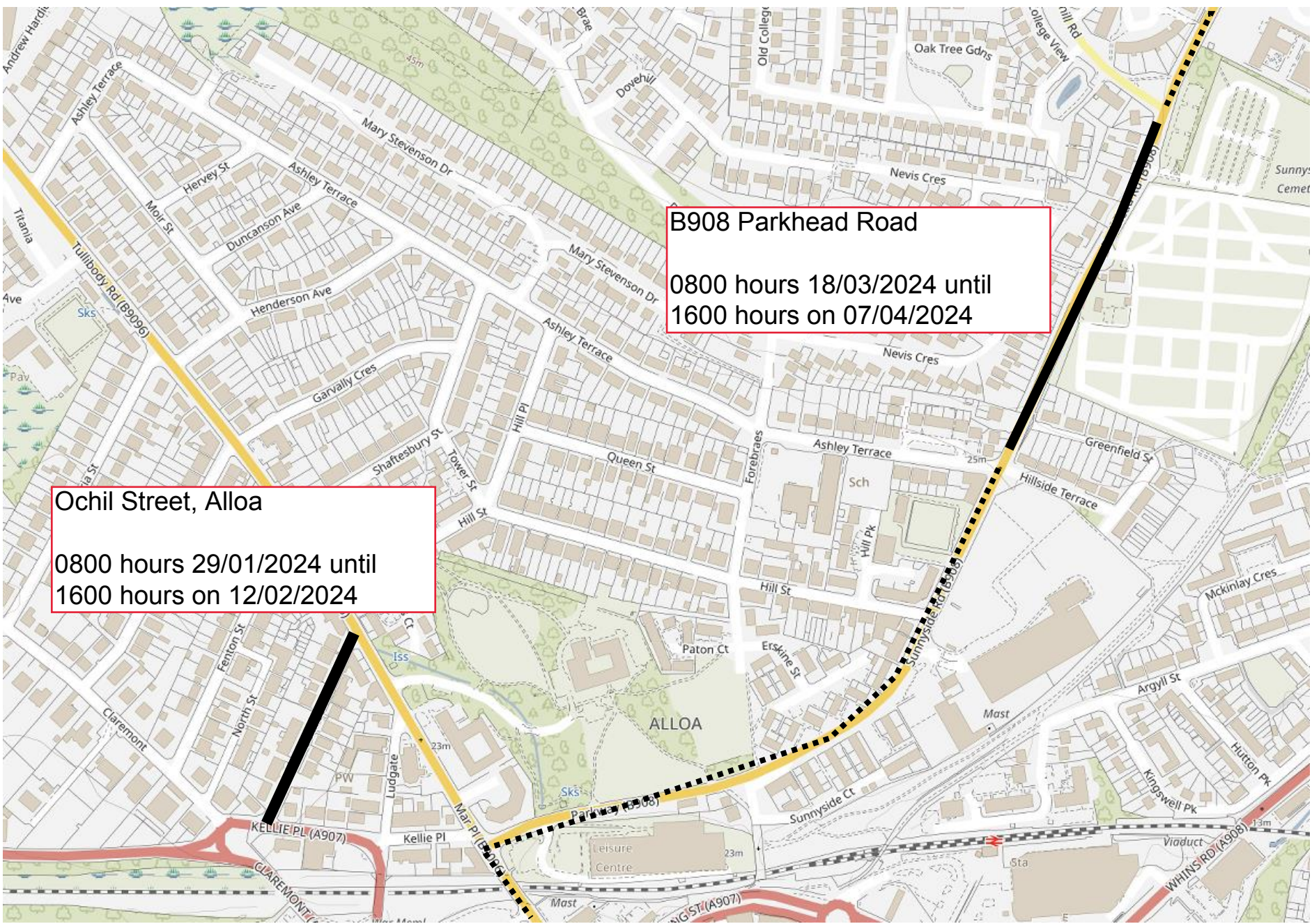
