

**THE CLACKMANNANSHIRE COUNCIL
(VARIOUS STREETS, CLACKMANNANSHIRE)
(40MPH SPEED LIMIT) AMENDMENT NO.1 ORDER 2024**

Clackmannanshire Council, in exercise of the powers conferred upon it by Sections 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act, hereby make the following Order:-

- (1) This Amendment Order may be cited as "The Clackmannanshire Council (Various Streets, Clackmannanshire) (40mph Speed Limit) Amendment No.1 Order 2024" and shall come into operation on 17 April 2024.
- (2) This Amendment Order amends "The Clackmannanshire Council (Various Streets, Clackmannanshire) (40mph Speed Limit) Order 2022" by adding to the Schedule to that Order, the additional lengths of road as detailed in the Schedule to this Amendment Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (3) A speed limit of 40 miles per hour is hereby imposed on the lengths of roads specified in the Schedule to this Order and no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the said lengths of roads.
- (4) The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

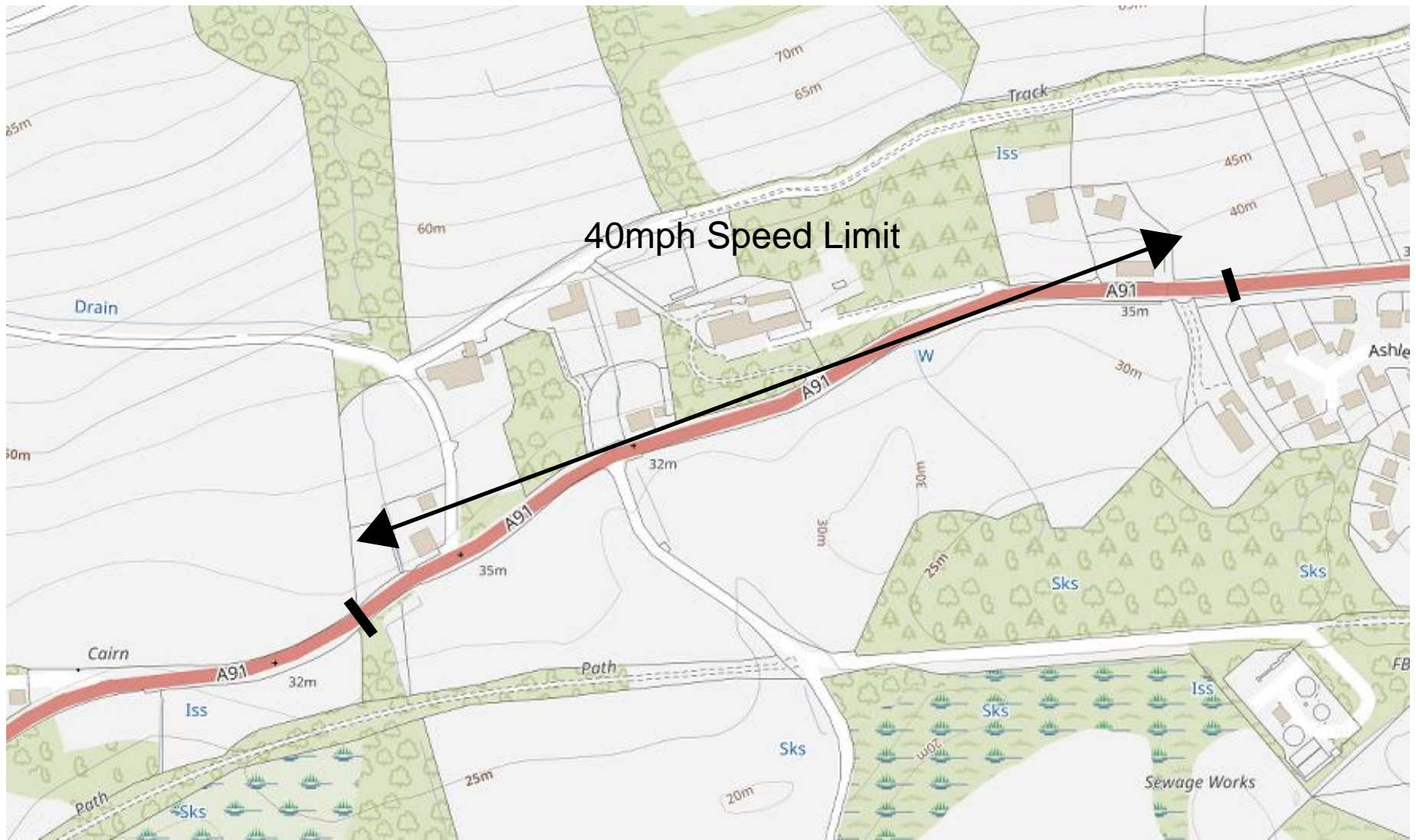
