The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary No Parking) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours until 1800 hours on Thursday 21<sup>st</sup> March 2024.
2. The effect of this Order is that there will be no parking at any time during:

The period from 0800 hours until 1800 hours on Thursday 21<sup>st</sup> March 2024, on the section of roads described in Schedule. The temporary prohibition of parking is required for iron work repairs.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary No Parking) Order 2023, under the Road Traffic Regulation Act 1984 (as amended) on 9<sup>th</sup> January 2024: where there will be a temporary no parking at **Castle Street, Alloa** (North Side - From a point 70 metres or thereby east of its junction with North Castle Street, westwards for a distance of 140 metres or thereby). **Castle Street, Alloa** (South Side - From a point 33 metres or there west of its junction with Lime Tree Walk, westwards for a distance of 175 metres or thereby). **North Castle Street, Alloa** (East Side - From its junction with Castle Street, northwards for a distance of 50 metres or thereby). **North Castle Street, Alloa** (West Side - From its junction with Castle Street, northwards for a distance of 70 metres or thereby). The order runs from 0800 hours until 1800 hours on Thursday 21<sup>st</sup> March 2024. The temporary prohibition of parking is required for iron work repairs. 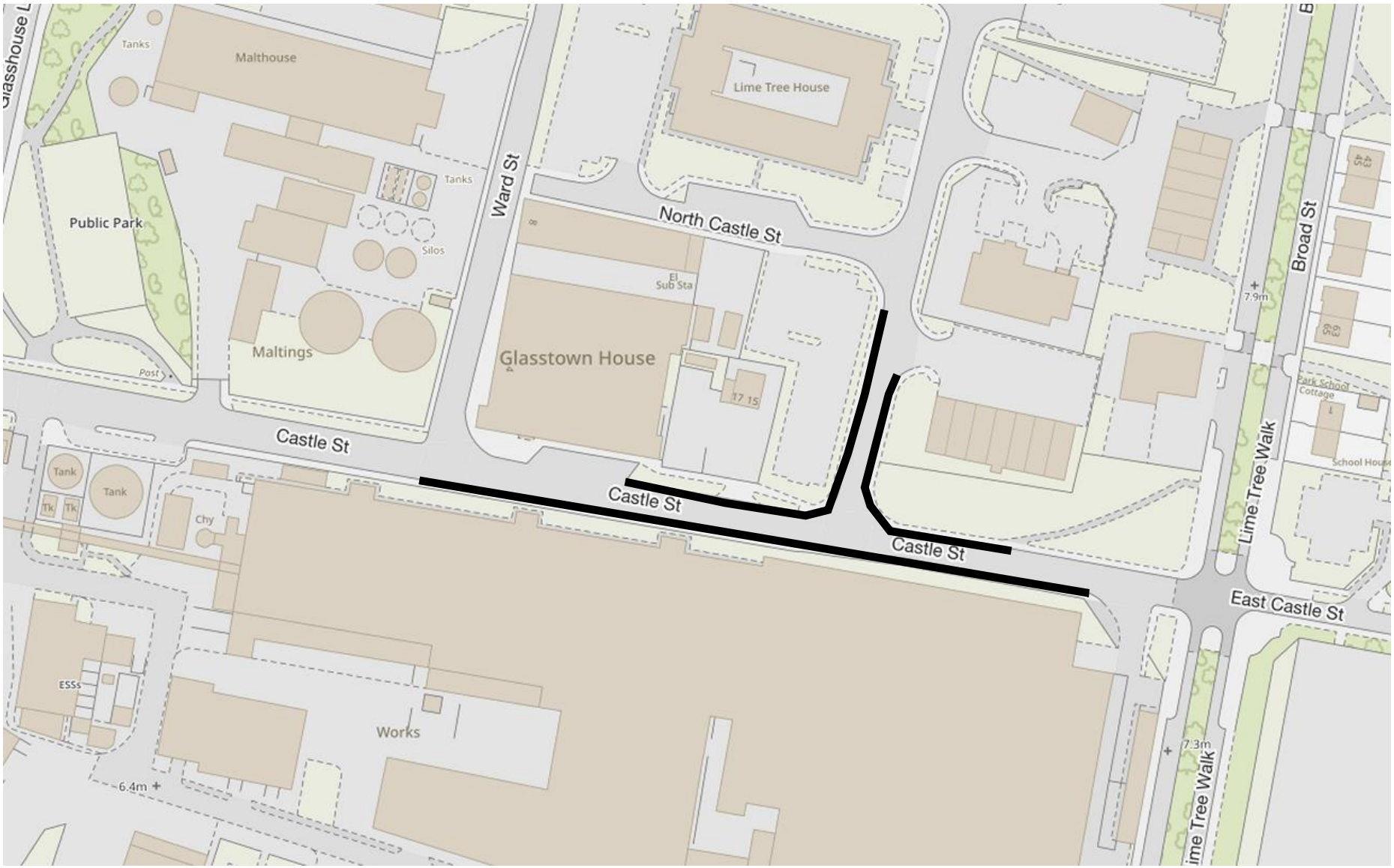
