

#### (BEDFORD PLACE, ALLOA) (TEMPORARY NO PARKING) ORDER 2024

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Bedford Place, Alloa) (Temporary No Parking) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Monday 6<sup>th</sup> May 2024 until 2000 hours on Tuesday 14<sup>th</sup> May 2024.
- 2. The effect of this Order is that there will be no parking at any time during:

The period from 0930 hours on Monday 6<sup>th</sup> May 2024 until 2000 hours on Tuesday 14<sup>th</sup> May 2024, on the section of roads described in Schedule. The temporary prohibition of parking is required for Scottish Water Repairs.


