



**(PRIMROSE STREET, ALLOA)
(TEMPORARY FOOTWAY CLOSURE AND NO PARKING RESTRICTION) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Primrose Street, Alloa) (Temporary Footway Closure and no Parking Restriction) Order 2024" and notwithstanding the date hereof, the Schedule 1 and schedule 2 shall come into operation from 0800 hours on Monday 24th June 2024 until 1600 hours on Wednesday 3rd July 2024.
2. The effect of this Order is that there will be a temporary footway closure and no parking restriction during:

The period from 0800 hours on Monday 24th June 2024 until 1600 hours on Wednesday 3rd July 2024, on the section of footway described in Schedule 1 and 2. The temporary footway closure and no parking restriction is required to excavate footway on behalf of SP Energy Networks and for pedestrian safety.
