

(VARIOUS STREETS, ALVA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Back Road, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 1200 hours until 1800 hours on Saturday 13th July 2024.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 1200 hours until 1800 hours on Saturday 13th July 2024, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for safety of participants during the Hill Race. Access for residents will be permitted where possible.

The Council has made "The Clackmannanshire Council (Various Streets, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 1st May 2024: Schedule - where there will be a temporary prohibition of driving, parking and loading at Beauclerc Street, Alva (From the east boundary of no.100 westwards until its junction with Back Road, a distance of 87 metres or thereby). Back Road, Alva (From its junction with Beauclerc Street westwards for a distance of 43 metres or thereby). Diversion Via Back Road, Grodwell Drive, A91, Queen Street, Beauclerc Street and vice versa). The order runs from 1200 hours until 1800 hours on Saturday 13th July 2024.
