



**(B908 ALVA ROAD, SAUCHIE)  
(TEMPORARY SPEED RESTRICTION) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B908 Alva Road, Sauchie) (Temporary Speed Restriction) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 12<sup>th</sup> August 2024 for a period of 18 months.
2. The effect of this Order shall be to reduce the speed to 30mph:

The period from 0800 hours on Monday 12<sup>th</sup> August 2024 for a period of 18 months, on the section of roads described in Schedule. The temporary speed restriction is required for road safety during construction works on the new housing development.

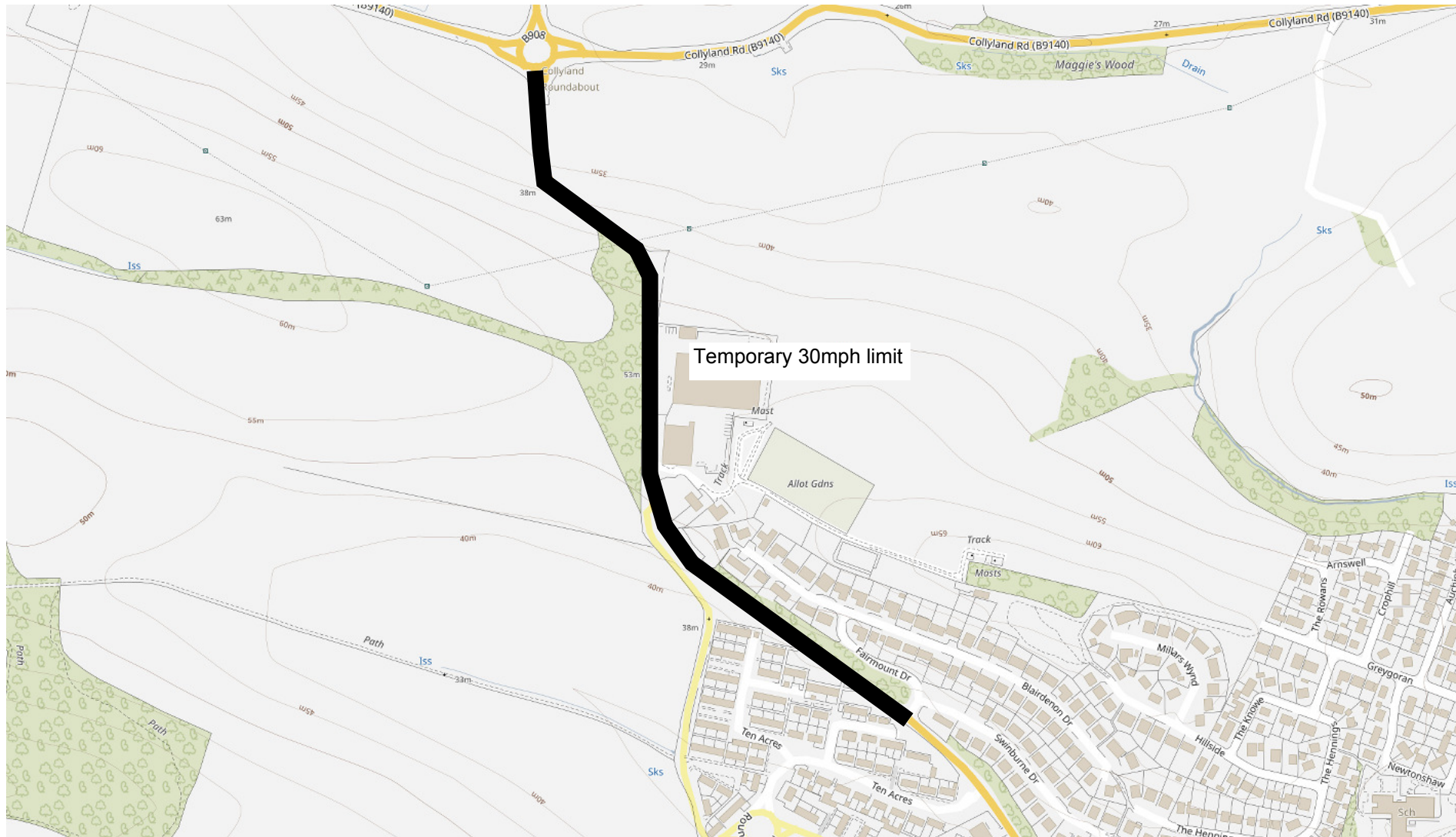
