

(ERSKINE STREET, ALVA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Erskine Street, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Thursday 29th August 2024 until 1700 hours on Friday 30th August 2024.
- 2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0930 hours on Thursday 29th August 2024 until 1700 hours on Friday 30th August 2024, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to provide a safe working area for engineers to access existing box and lay new ducting to provide fibre cabling for a customer.


