

(VARIOUS STREETS, ALVA) (TEMPORARY NO PARKING) ORDER 2024

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary No Parking) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 1730 hours until 2200 hours on Saturday 21st September 2024.
- 2. The effect of this Order is that there will be no parking at any time during:

The period from 1730 hours until 2200 hours on Saturday 21st September 2024, on the section of roads described in Schedule. The temporary prohibition of parking is required for safety during Alva Illuminations.

The Council has made "The Clackmannanshire Council (Various Streets, Alva) (Temporary No Parking) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 10th September 2024: where there will be a temporary no parking at **Brook Street**, **Alva** (Both Sides - From its junction with Ochil Road, northwards for a distance of 50 metres or thereby). **Brook Street**, **Alva** (Both Sides - From its junction with Ochil Road, southwards for a distance of 50 metres or thereby). **Beauclerc Street**, **Alva** (Both Sides - From its junction with Brook Street, westwards for a distance of 50 metres or thereby). **Ochil Road**, **Alva** (Both Sides - From its junction with Brook Street, eastwards for a distance of 50 metres or thereby). The order runs from 1730 hours until 2200 hours on Saturday 21st September 2024. The temporary prohibition of parking is required for safety during Alva Illuminations.
