## (RAMSEY TULLIS DRIVE, TULLIBODY) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Ramsey Tullis Drive, Tullibody) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours until 1800 hours on Wednesday 2<sup>nd</sup> October 2024.
- 2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0930 hours until 1800 hours on Wednesday 2<sup>nd</sup> October 2024, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for Scottish Water ironworks.

The Council has made "The Clackmannanshire Council (Ramsey Tullis Drive, Tullibody) (Temporary Prohibition of Driving, Parking and Loading) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 4<sup>th</sup> September 2024: where there will be a temporary prohibition of driving, parking and loading at **Ramsey Tullis Drive, Tullibody** (From its junction with Newbiggin Crescent, eastwards for a distance of 100 metres or thereby). **Ramsey Tullis Drive, Tullibody** (From a point 50 metres or thereby) east of its junction with Robert Knox Avenue, eastwards for a distance of 100 metres or thereby). No diversion available. Emergency Access will be maintained. The order runs from 0930 hours until 1800 hours on Wednesday 2<sup>nd</sup> October 2024.
