



**(C99 MARCHGLEN TO TILlicOUNTRY)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (C99 Marchglen to Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 28th October 2024 until 1600 hours on Friday 8th November 2024.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0800 hours on Monday 28th October 2024 until 1600 hours on Friday 8th November 2024, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for carriageway resurfacing and safety of the workforce and members of the public.

Diversion Via A908, A91, Lower Mill Street and vice versa. The order runs from 0800 hours on Monday 28th October 2024 until 1600 hours on Friday 8th November 2024. 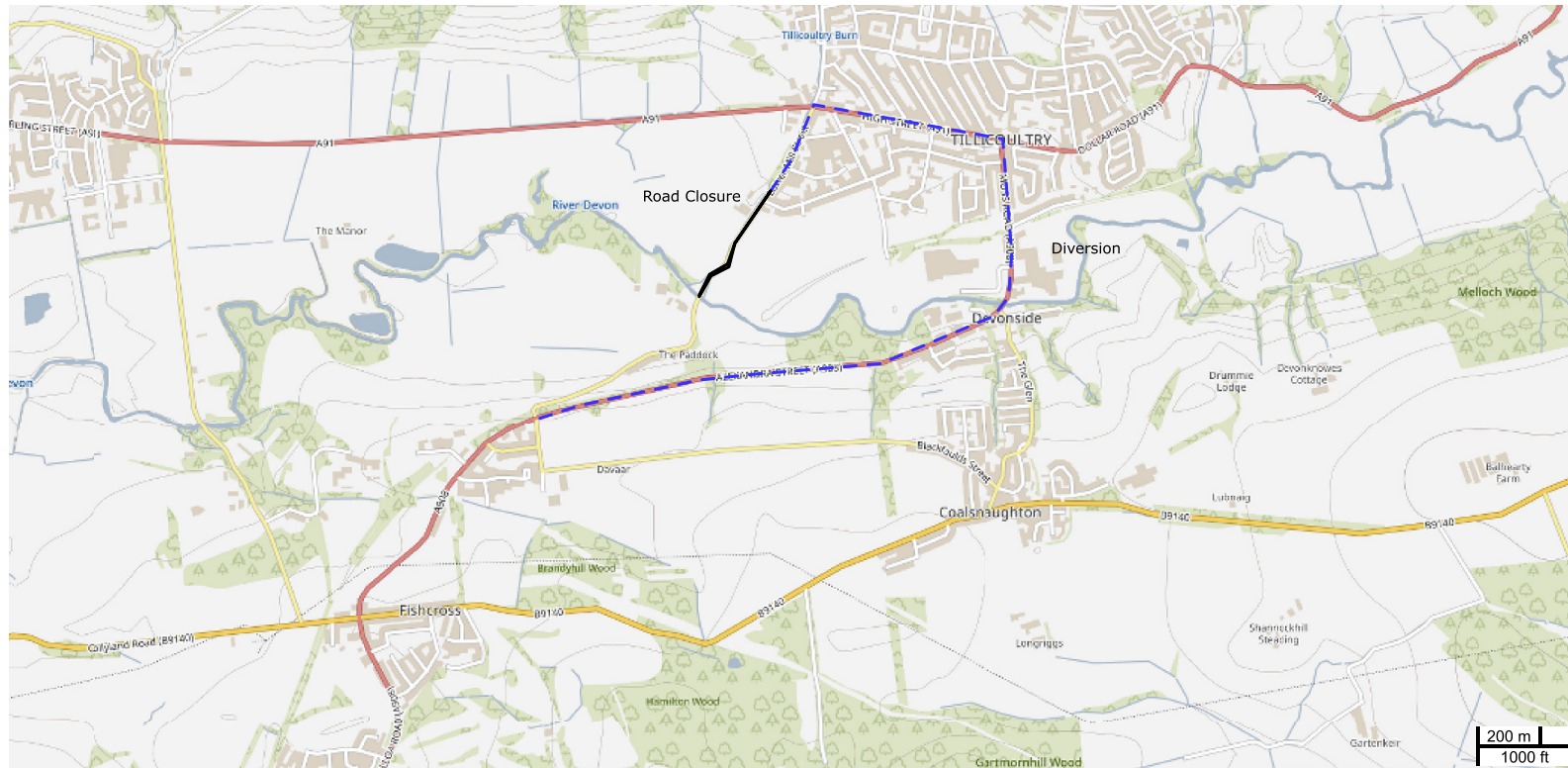
