The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 1600 hours until 2100 hours on Saturday 2nd November 2024 (contingency for Sunday 3rd November 2024).
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 1600 hours until 2100 hours on Saturday 2nd November 2024 (contingency for Sunday 3rd November 2024), on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is to allow the public to safely enter and exit West End Park, Alloa and to stop cars parking and blocking the road. Access will be maintained for residents, emergency services and pedestrians.


