



**(B913 SOLSGIRTH)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B913 Solsgirth) (Temporary Prohibition of Driving, Parking and Loading) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 4<sup>th</sup> November 2024 until 1600 hours on Monday 11<sup>th</sup> November 2024.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0800 hours on Monday 4<sup>th</sup> November 2024 until 1600 hours on Monday 11<sup>th</sup> November 2024, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for culvert replacement. Access to Solsgirth House is still available from the A977.

The Council has made "The Clackmannanshire Council (B913 Solsgirth) (Temporary Prohibition of Driving, Parking and Loading) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 1<sup>st</sup> October 2024: where there will be a temporary prohibition of driving, parking and loading at **B913 Solsgirth** (From a point 450 metres or thereby east of A91 junction eastwards for a distance of 390 metres). Diversion via A977, Woodside Road, B913 and vice versa. The order runs from 0800 hours on Monday 4<sup>th</sup> November 2024 until 1600 hours on Monday 11<sup>th</sup> November 2024. The temporary prohibition of driving, parking and loading is required for culvert replacement. Access to Solsgirth House is still available from the A977. 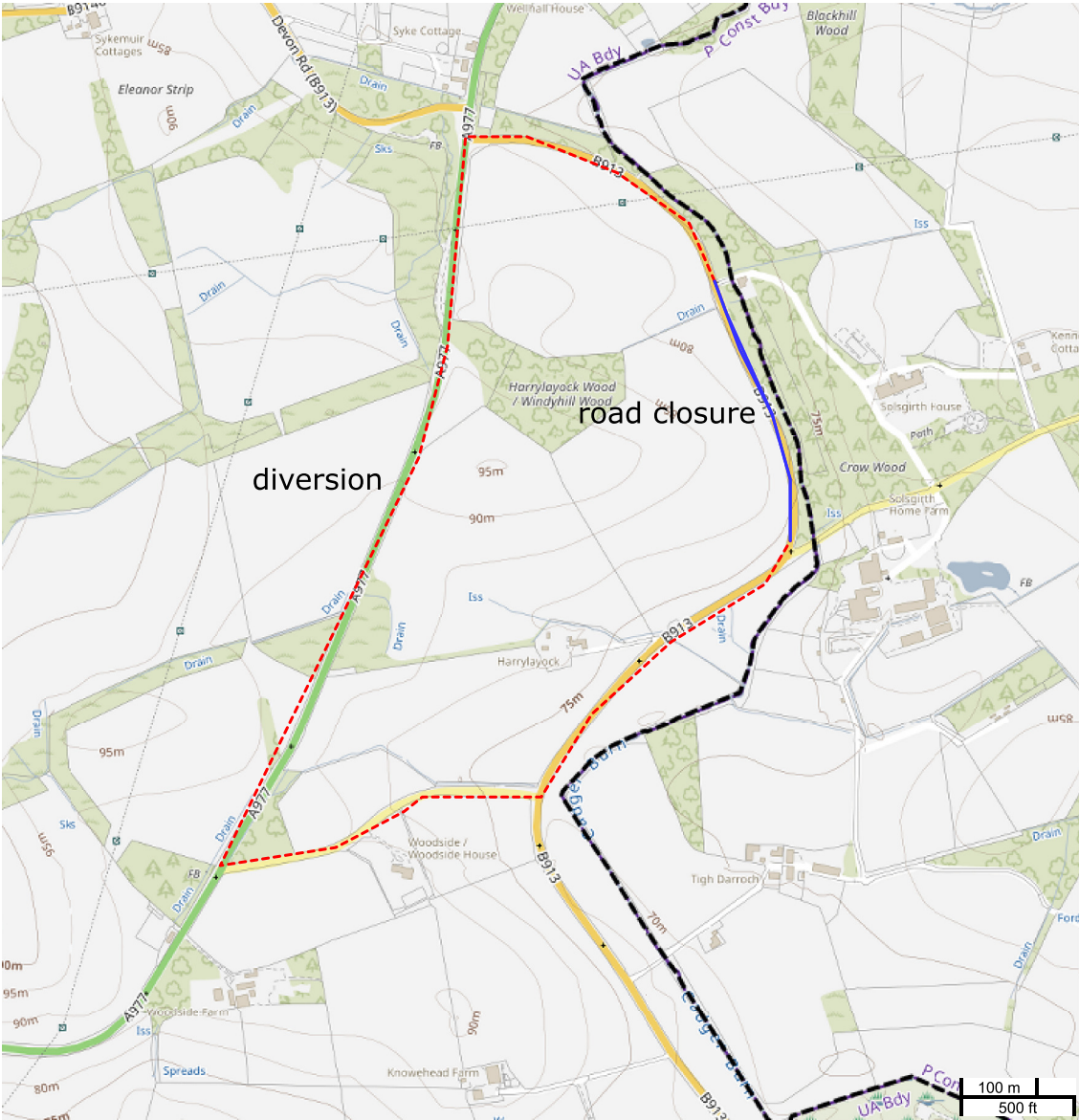
