



**(VARIOUS STREETS, ALLOA)  
(TEMPORARY PROHIBITION OF WAITING) ORDER 2024**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Waiting) Order 2024" and notwithstanding the date hereof, the Schedule shall come into operation at 0900 hours on Thursday 12<sup>th</sup> December 2024 for a period of 18 months.
2. The effect of this Order is that there will be a temporary prohibition of waiting at any time during:

The period from 0900 hours on Thursday 12<sup>th</sup> December 2024 for a period of 18 months, on the section of roads described in Schedule. The temporary prohibition of waiting at any time is required to keep the road clear during construction work at the Air Production Plant and to allow orders to be finalised.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Waiting) Order 2024, under the Road Traffic Regulation Act 1984 (as amended) on 21<sup>st</sup> November 2024: where there will be a temporary prohibition of waiting at any time at **Craigward, Alloa** (South Side - From a point 108 metres or thereby west of its junction with C95 Glasshouse Loan, westwards for a distance of 46 metres or thereby). **Kelliebank, Alloa** (North Side - From a point 10 metres west of its junction with Kelliebank (south) westwards for a distance of 70 metres or thereby). **Kelliebank, Alloa** (South Side - From a point 47 metres or thereby west of its junction with Kelliebank (south), westwards for a distance of 30 metres or thereby.). The order runs from 0900 hours on Thursday 12<sup>th</sup> December 2024 for a period of 18 months.
