The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Caledonian Road, Alloa) (Temporary No Parking) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Wednesday 5th February 2025 until 1530 hours on Thursday 6th February 2025.
- 2. The effect of this Order is that there will be a temporary no parking during:

The period from 0930 hours on Wednesday 5th February 2025 until 1530 hours on Thursday 6th February 2025, on the section of roads described in Schedule. The temporary no parking is in conjunction with 3way traffic lights for the safety of engineers to carry out underground civils works.


