

(BLACKGRANGE LEVEL CROSSING, BLACKGRANGE) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Blackgrange Level Crossing, Blackgrange) (Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation at 2100 hours on Saturday 8th March 2025 until 1000 hours on Sunday 9th March 2025.
- 2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 2100 hours on Saturday 8th March 2025 until 1000 hours on Sunday 9th March 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for remove/install level crossing for defects and inspections.

The Council has made "The Clackmannanshire Council (Blackgrange Level Crossing, Blackgrange) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 15th January 2025: where there will be a temporary prohibition of driving, parking and loading at **Blackgrange Level Crossing, Blackgrange** (From a point 250 metres south of its junction with A907 Alloa Road, southwards for a distance of 100 metres or thereby). No diversion available. The order runs from 2100 hours on Saturday 8th March 2025 until 1000 hours on Sunday 9th March 2025.
