



**(MEEKS PARK ROAD, FORESTMILL)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Meeks Park Road, Forestmill) (Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation at 0700 hours on Monday 3rd March 2025 until 1600 hours on Friday 7th March 2025.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0700 hours on Monday 3rd March 2025 until 1600 hours on Friday 7th March 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for bridge repairs.

The Council has made "The Clackmannanshire Council (Meeks Park Road, Forestmill) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 29th January 2025: where there will be a temporary prohibition of driving, parking and loading at **Meeks Park Road, Forestmill** (From its junction with A977 northwards until its junction with Aberdona Road, a distance of 960 metres or thereby). Diversion via Meeks Park Road, B9140, B913, A977 and vice versa. The order runs from 0700 hours on Monday 3rd March 2025 until 1600 hours on Friday 7th March 2025. 
