



**(CHAPELHILL, CLACKMANNAN)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Chapelhill, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation at 0900 hours until 1500 hours on Tuesday 11th March 2025 and Wednesday 12th March 2025.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0900 hours until 1500 hours on Tuesday 11th March 2025 and Wednesday 12th March 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for the safe removal of trees.

The Council has made "The Clackmannanshire Council (Chapelhill, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 18th February 2025: where there will be a temporary prohibition of driving, parking and loading at **Chapelhill, Clackmannan** (From a point 35 metres from its junction with Wellmyre eastwards for a distance of 105 metres or thereby). Diversion via Wellmyre, South Pilmuir Street, Chapelhill and vice versa. The order runs from 0900 hours until 1500 hours on Tuesday 11th March 2025 and Wednesday 12th March 2025.
