



**(UPPER HILLFOOT ROAD, DOLLAR)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Upper Hillfoot Road, Dollar) (Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours until 1700 hours on Thursday 17th April 2025.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0800 hours until 1700 hours on Thursday 17th April 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for BT pole replacement.

The Council has made "The Clackmannanshire Council (Upper Hillfoot Road, Dollar) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 5th February 2025: where there will be a temporary prohibition of driving, parking and loading at **Upper Hillfoot Road, Dollar** (From a point 135 metres or thereby west of its junction with A91, westwards for a distance of 70 metres or thereby). Diversion via Upper Hillfoot Road, Hillfoots Road, West Burnside, A91 and vice versa. The order runs from 0800 hours until 1700 hours on Thursday 17th April 2025. 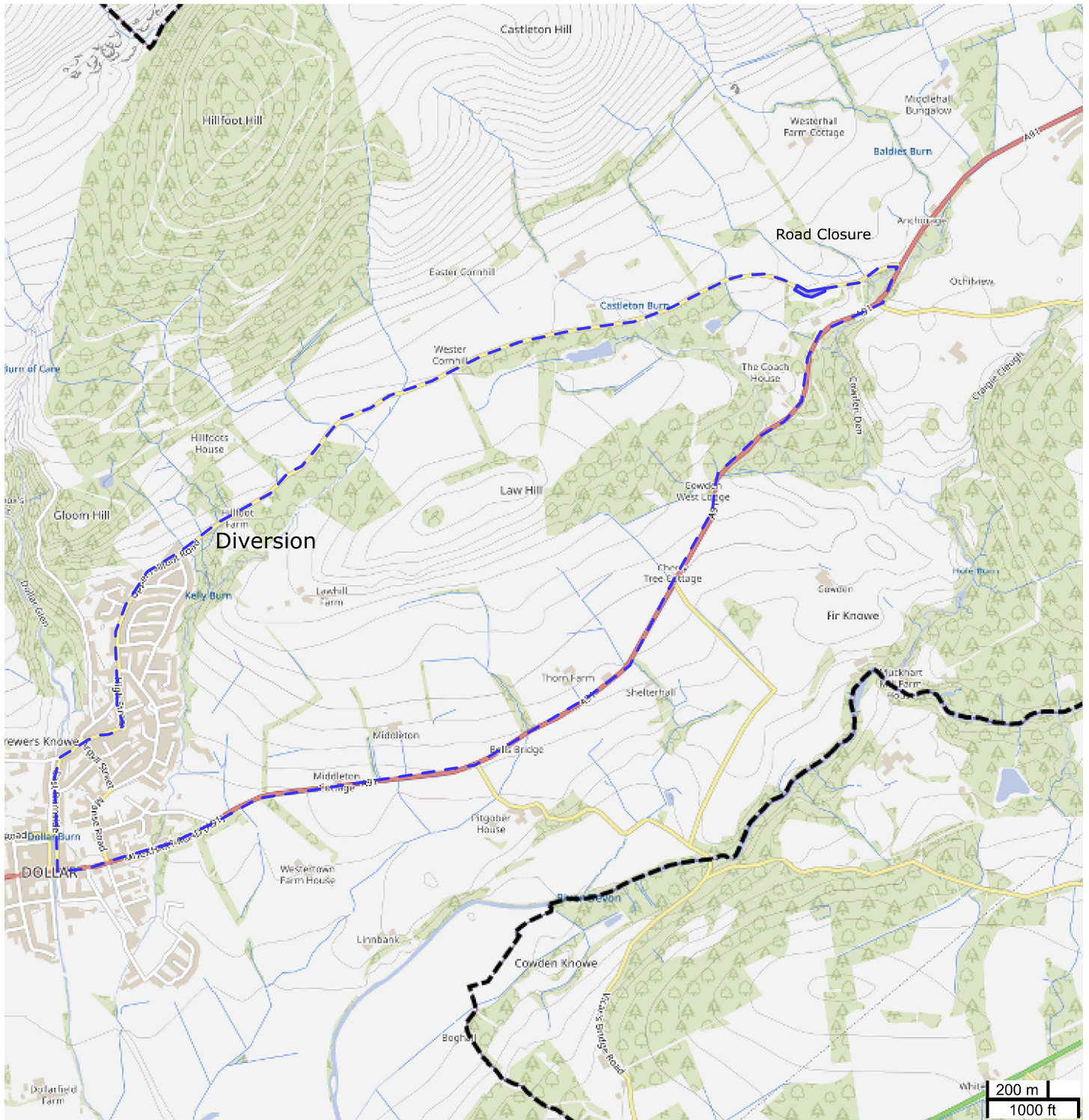
