

### (MAIN STREET WEST, MENSTRIE) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Main Street West, Menstrie)
  Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date
  hereof, the Schedule shall come into operation at 0800 hours on Monday 2<sup>nd</sup> June 2025 until 1600
  hours on Wednesday 11<sup>th</sup> June 2025.
- 2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0800 hours on Monday 2<sup>nd</sup> June 2025 until 1600 hours on Wednesday 11<sup>th</sup> June 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for carriageway resurfacing and safety of the workforce and members of the public.

The Council has made "The Clackmannanshire Council (A91 Main Street West, Menstrie) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 15<sup>th</sup> April 2025: where there will be a temporary prohibition of driving, parking and loading at **A91 Main Street West, Menstrie** (From the east side of its junction with Windsor Street, westwards for a distance of 125 metres or thereby). Diversion via A91, C101, B9140, A907, A91 and vice versa. The order runs from 0800 hours on Monday 2<sup>nd</sup> June 2025 until 1600 hours on Wednesday 11<sup>th</sup> June 2025. The temporary prohibition of driving, parking and loading is required for carriageway resurfacing and safety of the workforce and members of the public. 
