



**(A907 CLACKMANNAN ROAD, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 Clackmannan Road, Alloa) Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation each evening from 1900 hours until 0600 hours from Monday 30th June 2025 until Monday 14th July 2025.
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 1900 hours until 0600 hours each evening from Monday 30th June 2025 until Monday 14th July 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for carriageway resurfacing and safety of the workforce and members of the public.

The Council has made "The Clackmannanshire Council (A907 Clackmannan Road, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 20th May 2025: where there will be a temporary prohibition of driving, parking and loading at **A907 Clackmannan Road, Alloa** (From its junction with Clackmannan Road Roundabout westwards until west kerbline of Hawkhill, a distance of 350 metres or thereby). Diversion via B909, A908, A907 and vice versa (low bridge on this route). The order runs from 1900 hours until 0600 hours each evening from Monday 30th June 2025 until Monday 14th July 2025. The temporary prohibition of driving, parking and loading is required for carriageway resurfacing and safety of the workforce and members of the public. 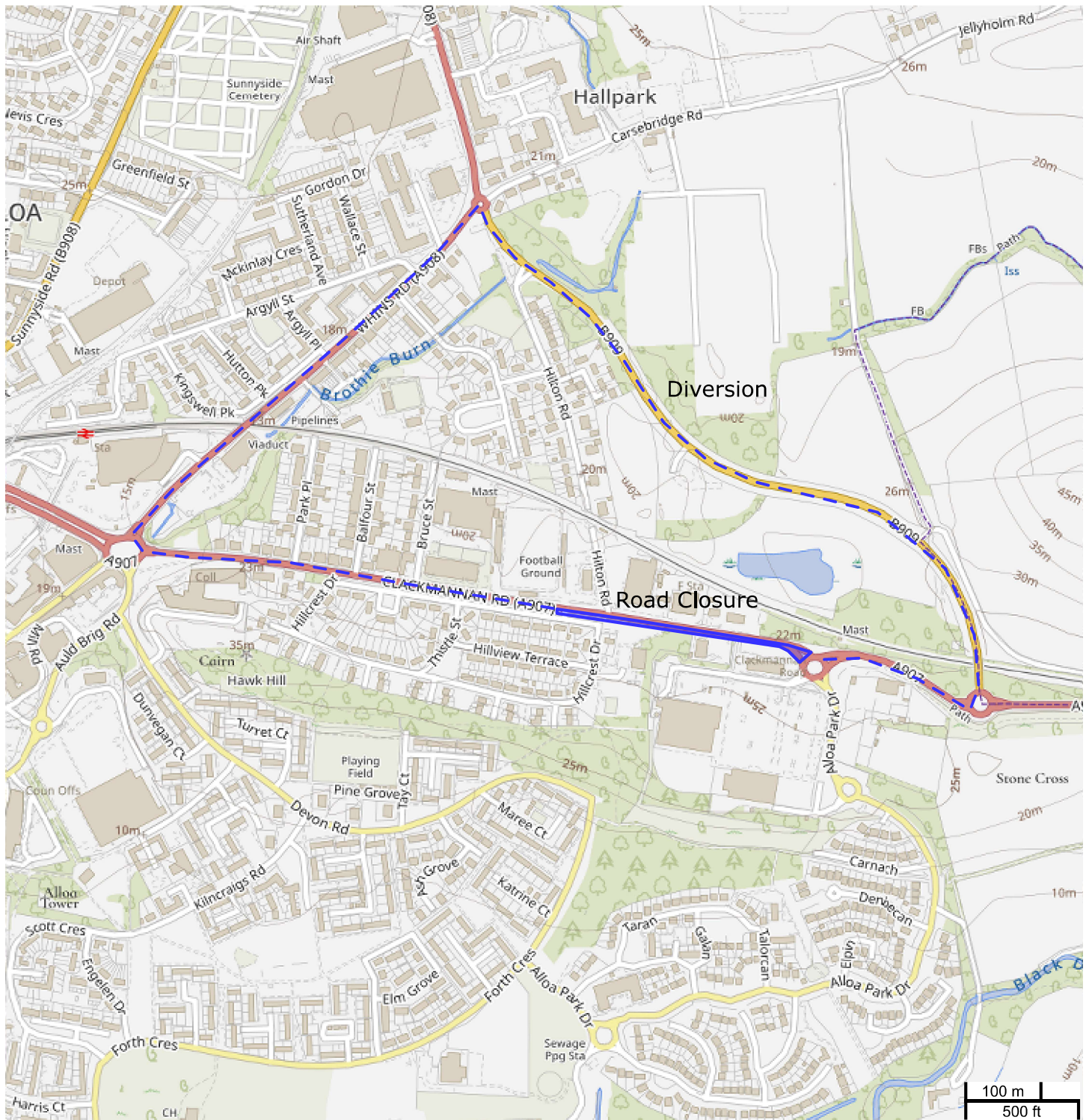
