

## (JAMIESON GARDENS, TILLICOULTRY) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Jamieson Gardens, Tillicoultry)
   Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date
   hereof, the Schedule shall come into operation at 0930 hours on Monday 14<sup>th</sup> July 2025 until 2359
   hours on Wednesday 23<sup>rd</sup> July 2025.
- 2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0930 hours on Monday 14<sup>th</sup> July 2025 until 2359 hours on Wednesday 23<sup>rd</sup> July 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required for planned works by Scottish Water.

The order runs from 0930 hours on Monday 14<sup>th</sup> July 2025 until 2359 hours on Wednesday 23<sup>rd</sup> July 2025.
