



**(VARIOUS STREETS, CAMBUS AND TULLIBODY)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Cambus and Tullibody) Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 14th July 2025 until 1600 hours on Friday 1st August 2025 (Third week of the closure is for contingency for bad weather/delays).
2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0800 hours on Monday 14th July 2025 until 1600 hours on Friday 1st August 2025, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is carriageway resurfacing and safety of the workforce and members of the public.

The Council has made "The Clackmannanshire Council (Various Streets, Cambus and Tullibody) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 28th May 2025: where there will be a temporary prohibition of driving, parking and loading at **A907 Alloa Road, Cambus** (From a point 100 metres east of its junction with Park Terrace, westwards for a distance of 500 metres or thereby). **Park Terrace, Tullibody** (From its junction with A907 Alloa Road, northwards for a distance of 150 metres or thereby). Diversion – Via A907, B9096, A907 and vice versa. Access for Cambus residents from west side only. The order runs from 0800 hours on Monday 14th July 2025 until 1600 hours on Friday 1st August 2025, third week of the closure is for contingency for bad weather/delays. 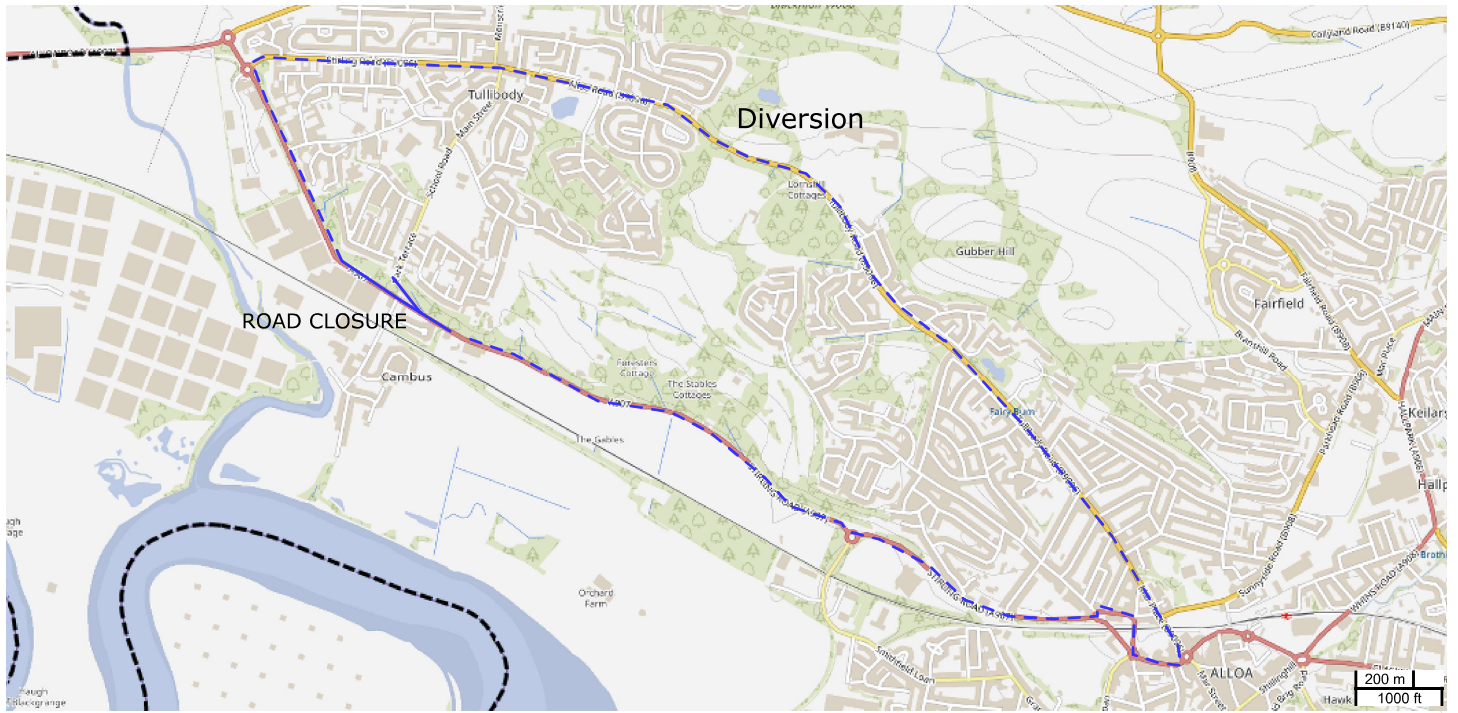
