2. The effect of this Order is that there will be a rolling road closure during:

The period from 0900 hours until 1000 hours on Saturday 5<sup>th</sup> July 2025, on the section of roads described in Schedule. The temporary rolling closure is required for safety during Kenneth Aitken Memorial event.

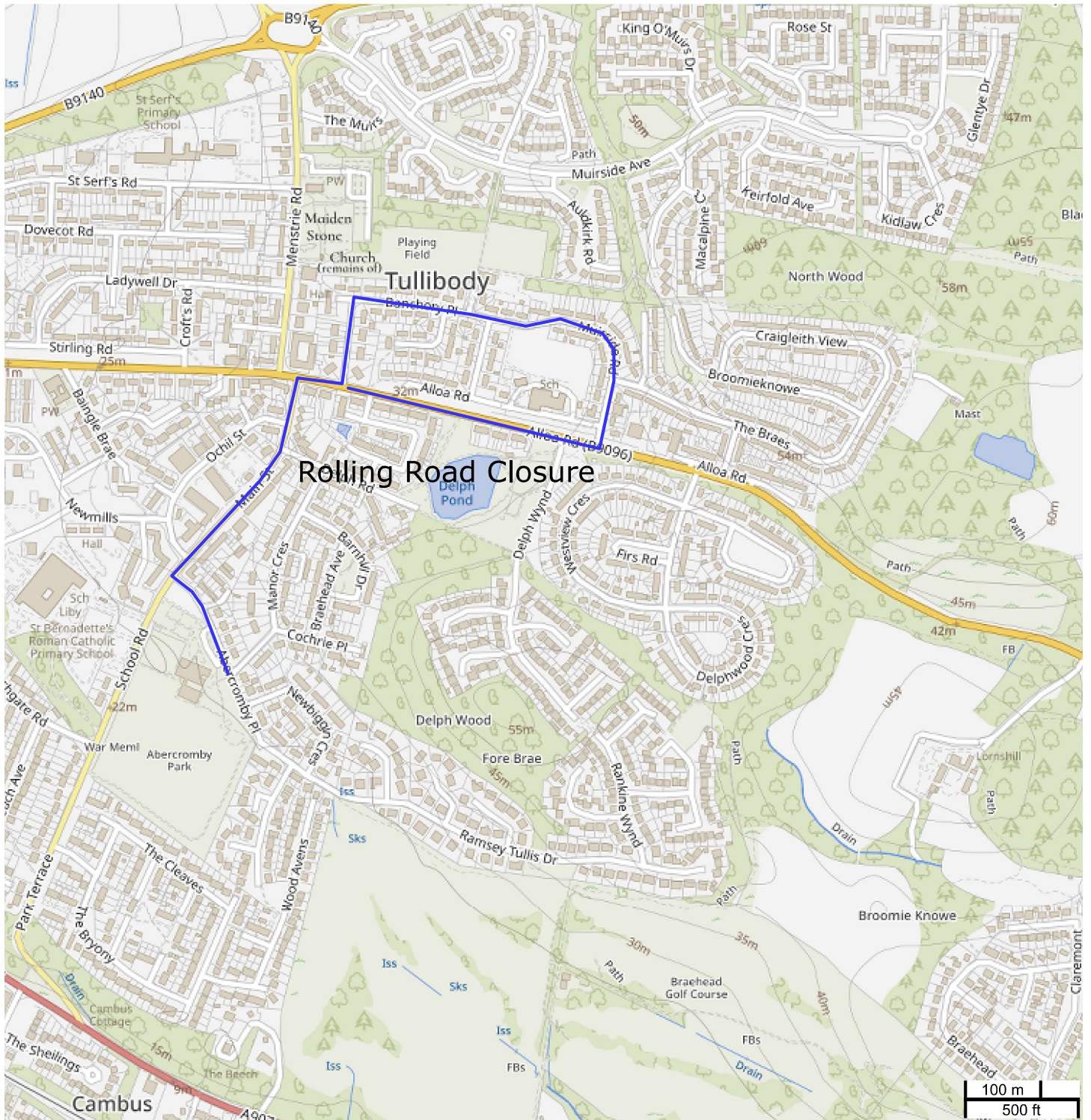
