The period from 0930 hours until 1800 hours on Friday 25<sup>th</sup> July 2025, on the section of roads described in Schedule. The temporary no parking is in conjunction with traffic lights for Scottish Water works.

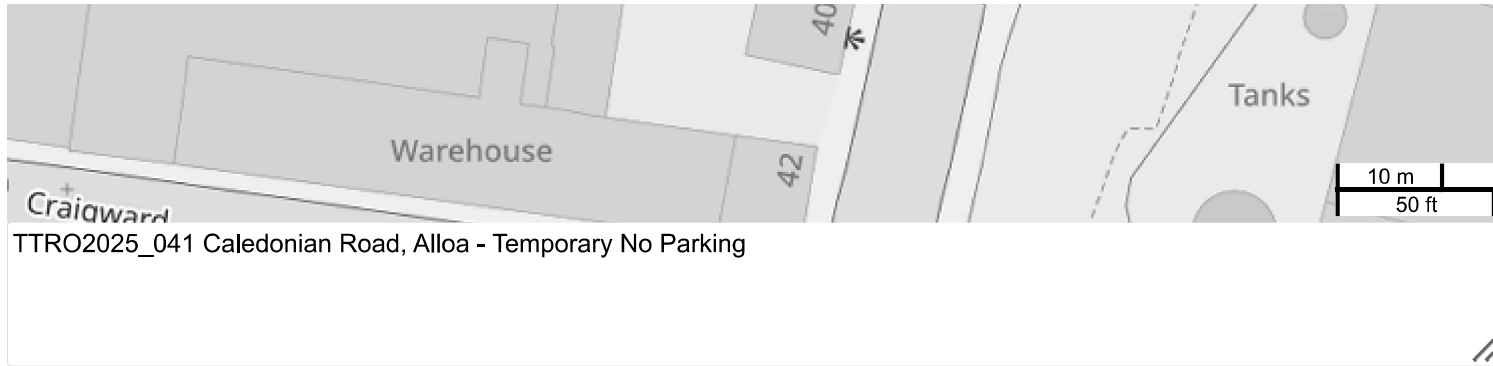
