



**(WHINS ROAD, ALLOA)
(TEMPORARY FOOTWAY CLOSURE) ORDER 2025**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Whins Road, Alloa) (Temporary Footway Closure) Order 2025" and notwithstanding the date hereof, the Schedule 1 shall come into operation at 0800 hours on Monday 4th August 2025 until 1600 hours on Wednesday 6th August 2025.
2. The effect of this Order is that there will be a temporary footway closure at any time during:

The period from 0800 hours on Monday 4th August 2025 until 1600 hours on Wednesday 6th August 2025, on the section of roads described in Schedule 1. The temporary footway closure is required for assemble and crane roof on to flame damaged property.

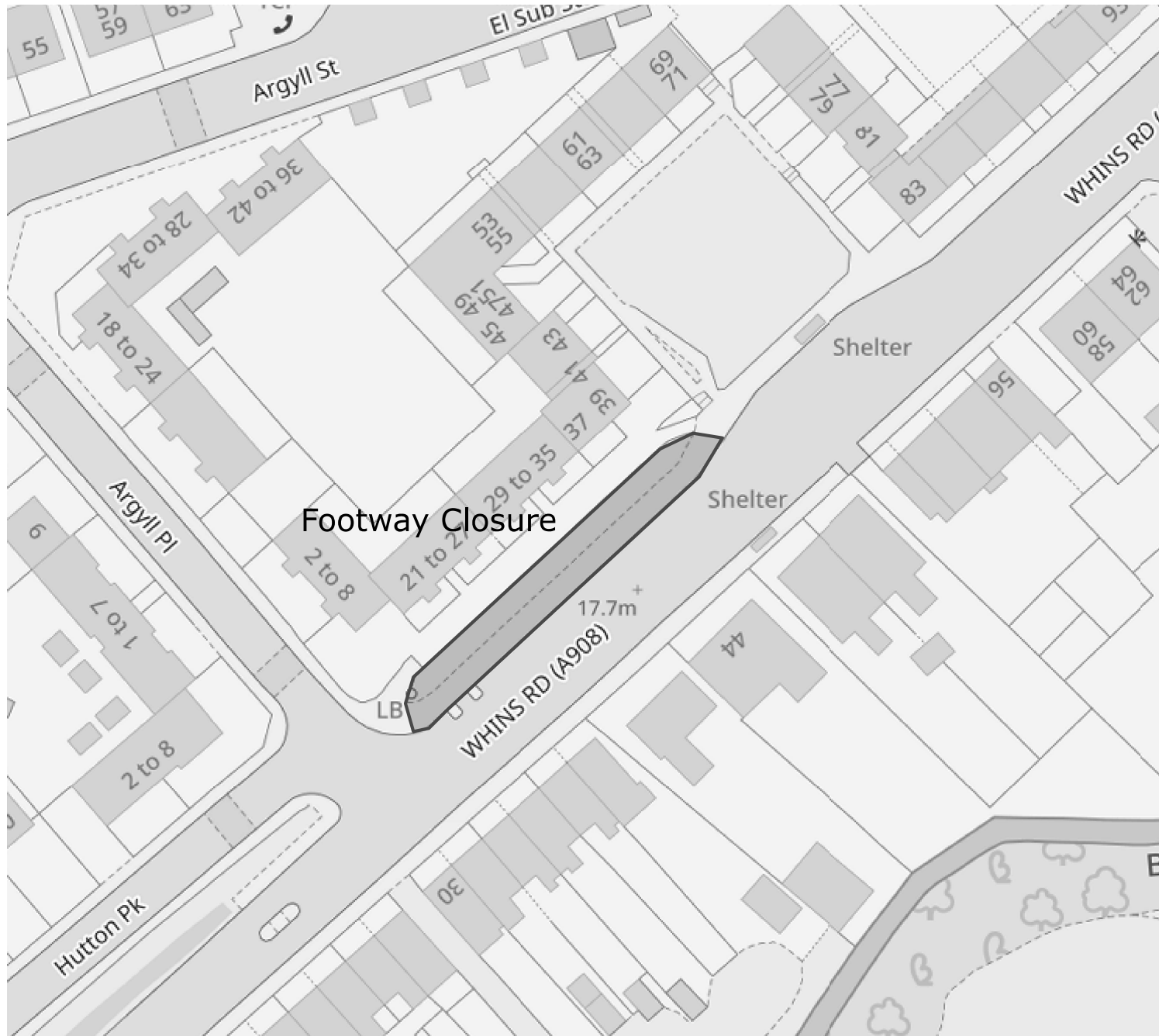

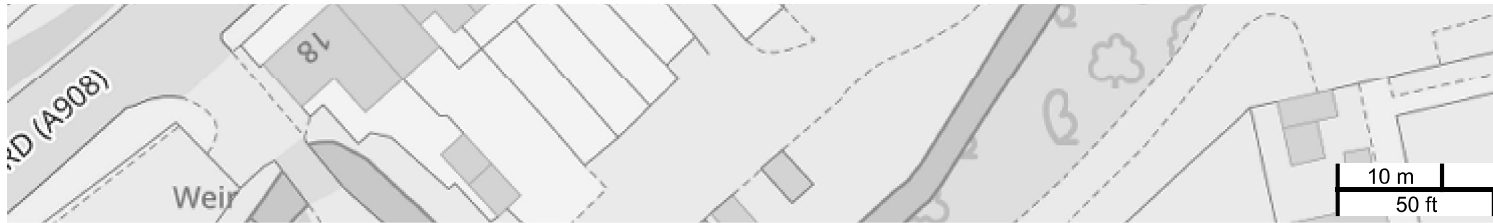
