

(ALLOA ROAD, CLACKMANNAN) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2025

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Alloa Road, Clackmannan) Temporary Prohibition of Driving, Parking and Loading) Order 2025" and notwithstanding the date hereof, the Schedule 1 shall come into operation from 0730 hours on Monday 27th October 2025 until 1600 hours on Friday 7th November 2025.
- 2. The effect of this Order is that there will be no driving, parking and loading at any time during:

The period from 0730 hours on Monday 27th October 2025 until 1600 hours on Friday 7th November 2025, on the section of roads described in Schedule 1. The temporary prohibition of driving, parking and loading is required to facilitate carriageway resurfacing.

The Council has made "The Clackmannanshire Council (Alloa Road, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2025, under the Road Traffic Regulation Act 1984 (as amended) on 2nd September 2025: Schedule 1 where there will be a temporary prohibition of driving, parking and loading at **Alloa Road, Clackmannan** (From its junction with Brucefield Crescent northwards for a distance of 460 metres or thereby). Diversion via C59 Alloa Road, A907 Clackmannan Bypass, B910 Alloa Road and vice versa. The order runs from 0730 hours on Monday 27th October 2025 until 1600 hours on Friday 7th November 2025.
